

NAVIGATING THE EPA REGULATED VESSELS UNIVERSE



AVAILABILITY OF THE 2013 VESSEL GENERAL PERMIT (VGP) AND SUPPORTING RESOURCES

The second Vessel General Permit (VGP) was finalized on March 28, 2013, to authorize discharges incidental to the normal discharge of operations of commercial vessels. The 2013 VGP, which has an effective date of December 19, 2013, will replace the 2008 Vessel General Permit. Coverage under the 2008 VGP terminates for all vessels on December 19, 2013.



EPA has not yet finalized the Small Vessel General Permit, but intends to do so in early 2014.



THE NEW 2013 VGP eNOI SYSTEM

The vessels eNOI system and public search page have been redesigned. The NOI system was released to the public on September 30, 2013.

The new eNOI system has an improved userfriendly interface and the following key enhancements:

- Help text adjacent to every question
- Data validation checks for many of the fields
- · Pick lists for many of the fields
- Easy submission of revised NOIs
- Automatic transfer of the existing permit number and data from the 2008 VGP system
- Combined NOI, NOT, and annual report (including DMRs) data
- System checks to ensure complete data reporting

Keep in mind that the 2013 VGP <u>requires</u> use of the eNOI system unless the vessel owner/operator obtains a temporary waiver, in writing, from EPA. The 2008 VGP eNOI system will no longer be available after December 19, 2013.
