> The Local Government Advisory Committee appreciates your leadership in setting forth the goals and objectives of the Draft FY2014-2018 EPA Strategic Plan (The Plan). - Furthermore, the LGAC urges EPA to build flexibility into its implementation of its regulatory, enforcement and granting authorities for state, tribal and local governments to address environmental challenges.
- ➤ Likewise, the LGAC also encourages the principles EPA has set forth to pursue new technological advances and tools which will aide and increase our effectiveness in environmental progress.
- > Particularly, we point out the continuous needs for local, state and tribal governments for sharing environmental data which will enhance our ability at the local level to achieve broad based benefits for planning and implementation.
- The LGAC also commends the EPA for its efforts to close the gap in health disparities for the underserved and disadvantaged communities, including environmental justice concerns. We believe this effort should also be extended to address growing health and environmental concerns of small communities under 10,000 which are often challenged in providing the very basics of infrastructure for clean air and water.
- The LGAC endorses the approach that the EPA has made in linking the Strategic Plan to the Climate Action Plan and Implementation Plans. This cross-linkage ensures quantifiable and measurable results to better support local preparedness and resilience-building efforts.
- > The Plan's collaborative and watershed-based approach to protecting and restoring watersheds and aquatic ecosystems is notable and appreciated by the LGAC.
- > The LGAC also acknowledges that the ten EPA Regional offices provide direct on the ground assistance for state, tribal and local governments.

Overall, the Draft Strategic Plan embraces several important tenets of collaboration and cooperation to improve the health of our nation's environment, economy and people. The LGAC congratulates the EPA on drafting a Strategic Plan that provides an outstanding foundation for advancing environmental stewardship nationally and locally. The EPA staff should be commended for their work to provide such an inclusive plan of action for the future.
