Allowable activities can be found in Subtitle G: "Diesel Emissions Reduction," Section 793, *State Grant and Loan Programs* of the Energy Policy Act of 2005 and other provisions of Subtitle G. The projects must all reduce diesel emissions.

Please note that the Fiscal Year 2011 funds will be added to the multi-year State Clean Diesel Program Fiscal Year 2008 through 2010 award to participating states.

## FUNDING ALLOCATION

The State of [State Name] understands that based on the allocation formula outlined in the Energy Policy Act of 2005, Subtitle G, Section 793, Fiscal Year 2011 base funds will be 1.887% of the 20% of the Congressional Appropriation and can average approximately \$180,000 per State. Awards may be higher or lower depending on the number of States participating (notification of the final amount is expected to occur by **Monday, May 23, 2011**). States electing to match the entire base EPA State Clean Diesel Program funds will be awarded an additional amount of approximately \$90,000. If there are fewer than 53 participating organizations, then each participating state would receive more than the estimated \$180,000 base funding amount, increasing the match amount required to receive the bonus funds.

Note: The source of match provided by the State will need to be approved by EPA.

## APPLICATION AND WORKPLAN
