

PUBLIC NOTICE

Proposed Permit Decision for the Evoqua Water Technologies LLC Facility near Parker, Arizona



WHAT THIS NOTICE IS ABOUT: The United States Environmental Protection Agency (EPA) is requesting public comment on a proposal to issue a hazardous waste management permit for the **Evoqua Water Technologies LLC facility located at the Colorado River Indian Tribes' Reservation, 2523 Mutahar Street near Parker, Arizona**. The purpose of EPA's proposal to issue a permit would be to allow the facility to process and treat spent (used) carbon, some of which is contaminated with hazardous waste, for reuse as clean carbon. Based on the facility operator's Human Health and Ecological Risk Assessment, EPA proposes to impose conditions on the facility operations so that there is no unreasonable risk to human health and the environment. The public is invited to provide its comments to EPA's proposal, as set forth below.

ATTEND A PUBLIC MEETING: EPA invites you to attend a Public Meeting and Public Hearing to discuss the proposed permit decision and to collect verbal and written comments. The meeting will be held November 1, 2016, in the Mohave Conference Room at the Bluewater Resort and Casino, located at 11300 Resort Drive, Parker, Arizona, 85344. Phone number: (928) 669-7000.
