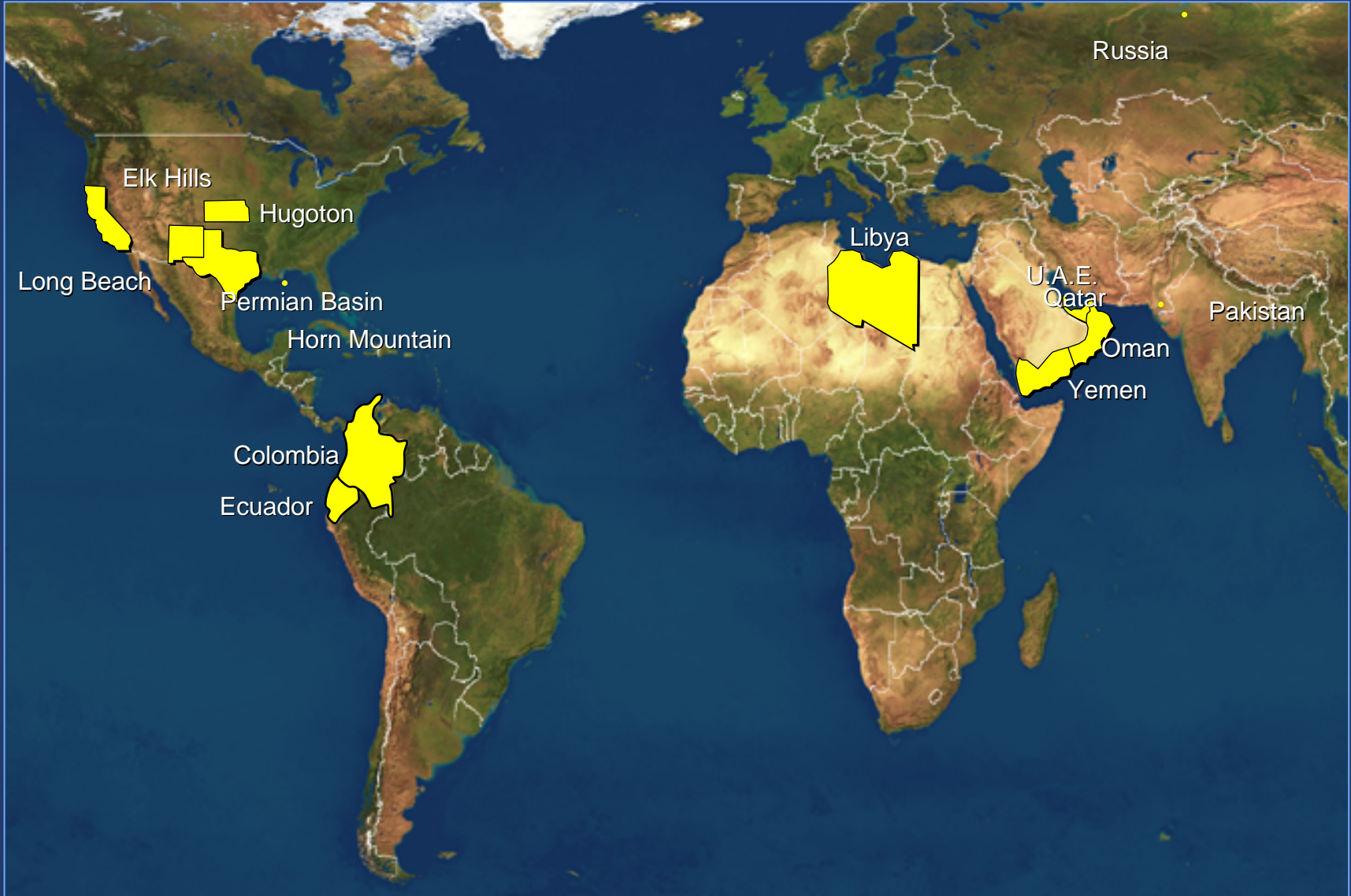

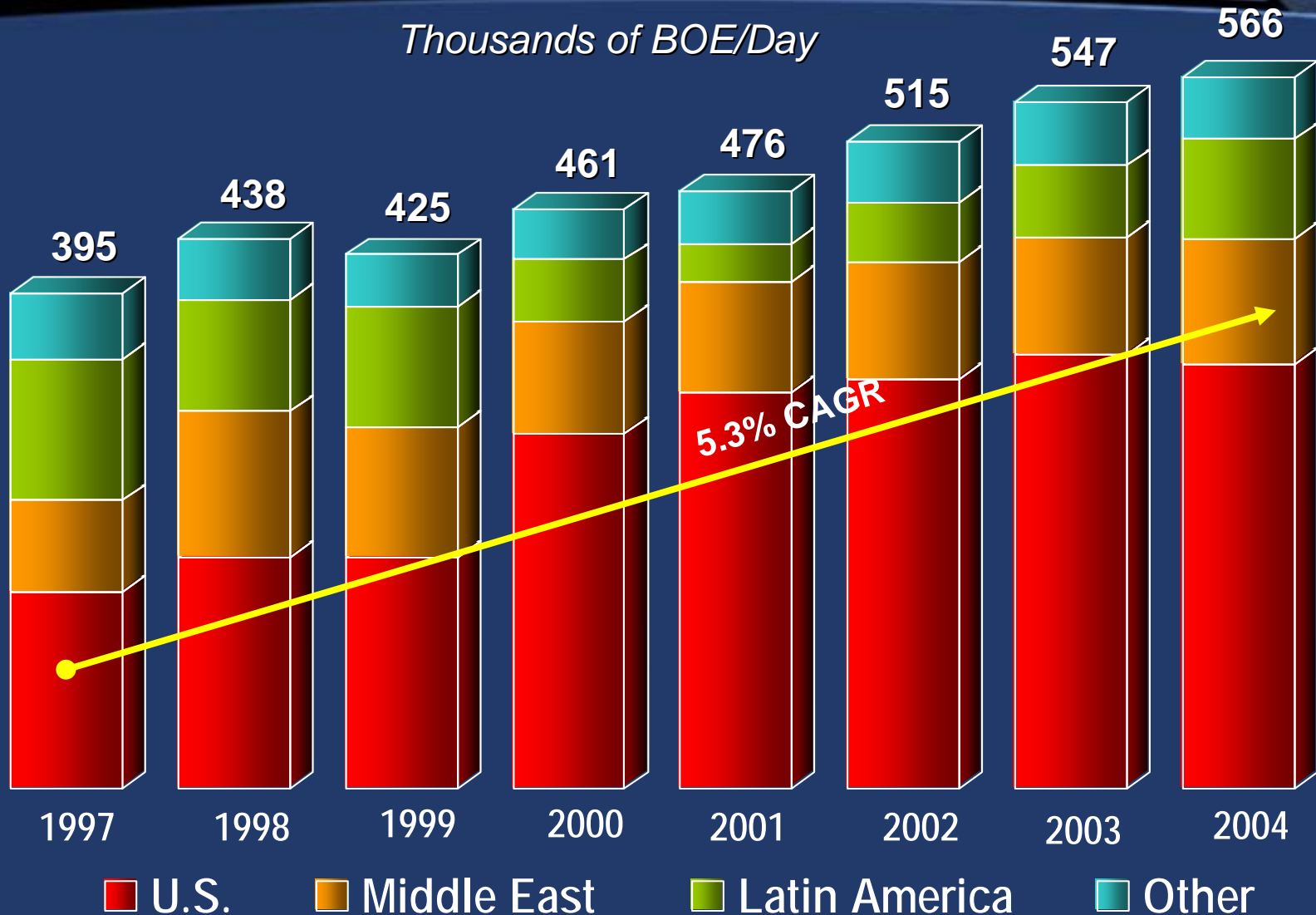
# Worldwide Operations



# Worldwide Production

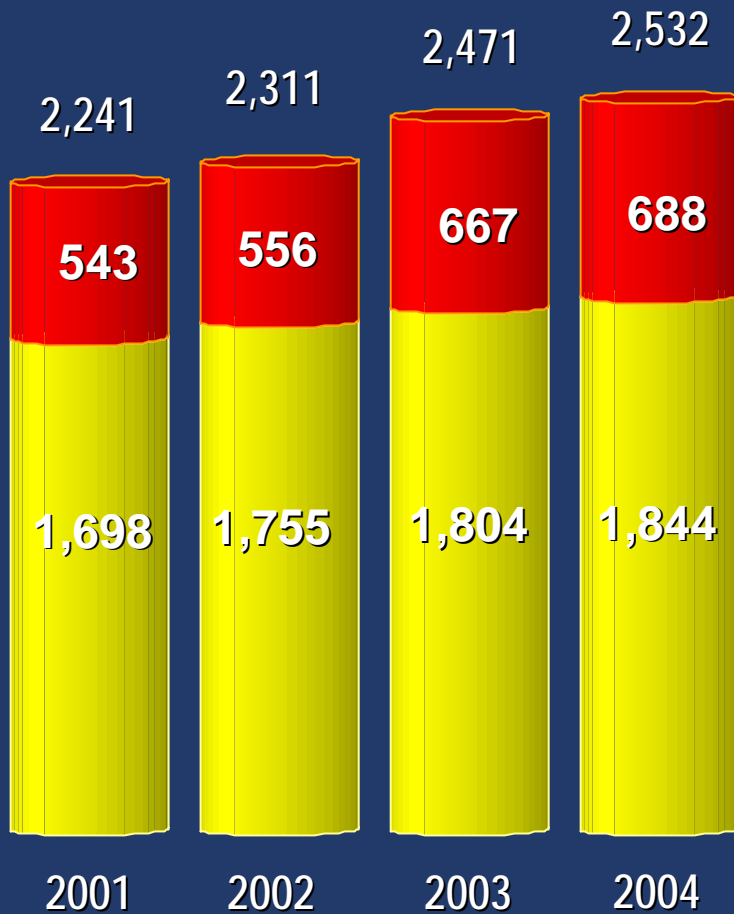

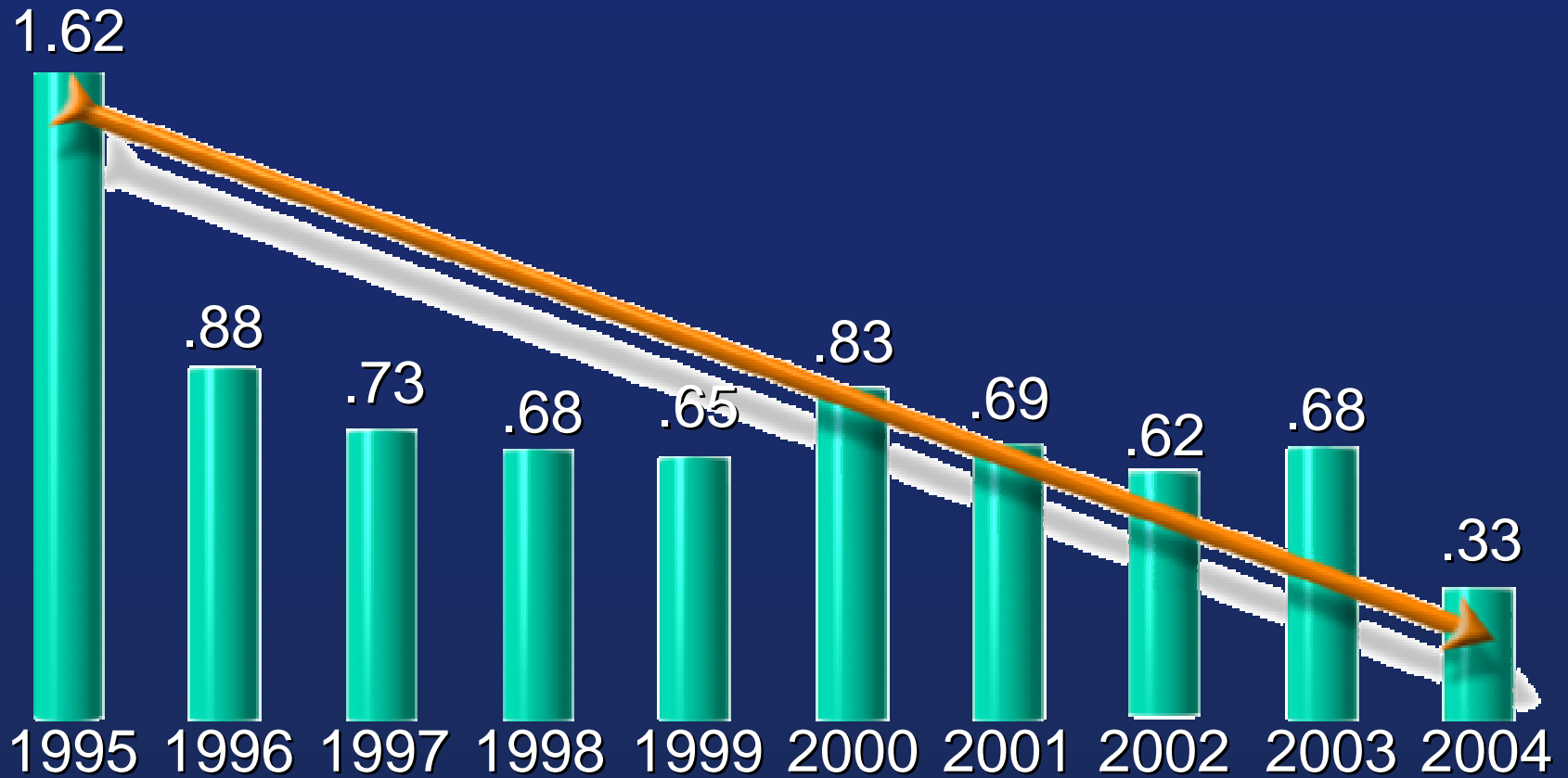

## Oxy Employee Injury and Illness Rate *(per 100 workers per year)*

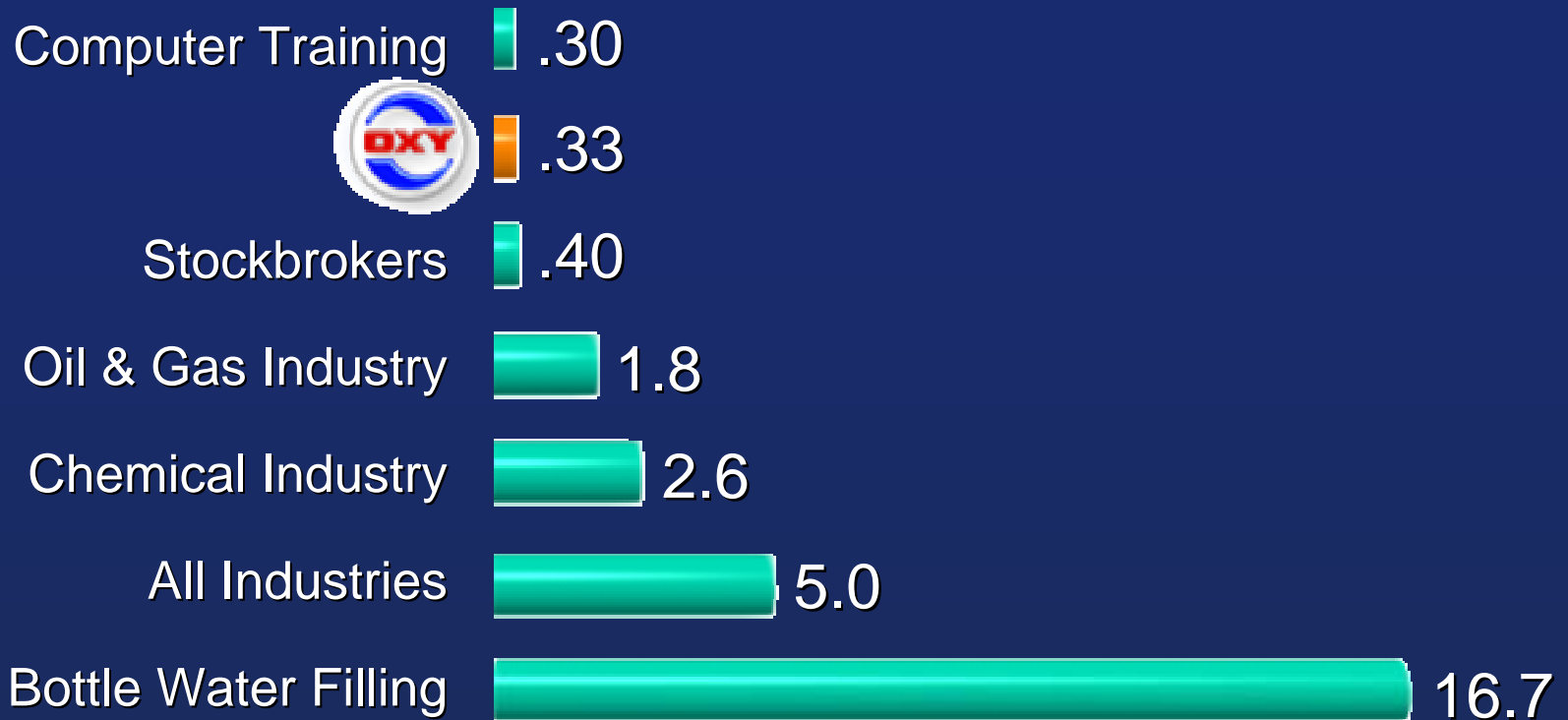

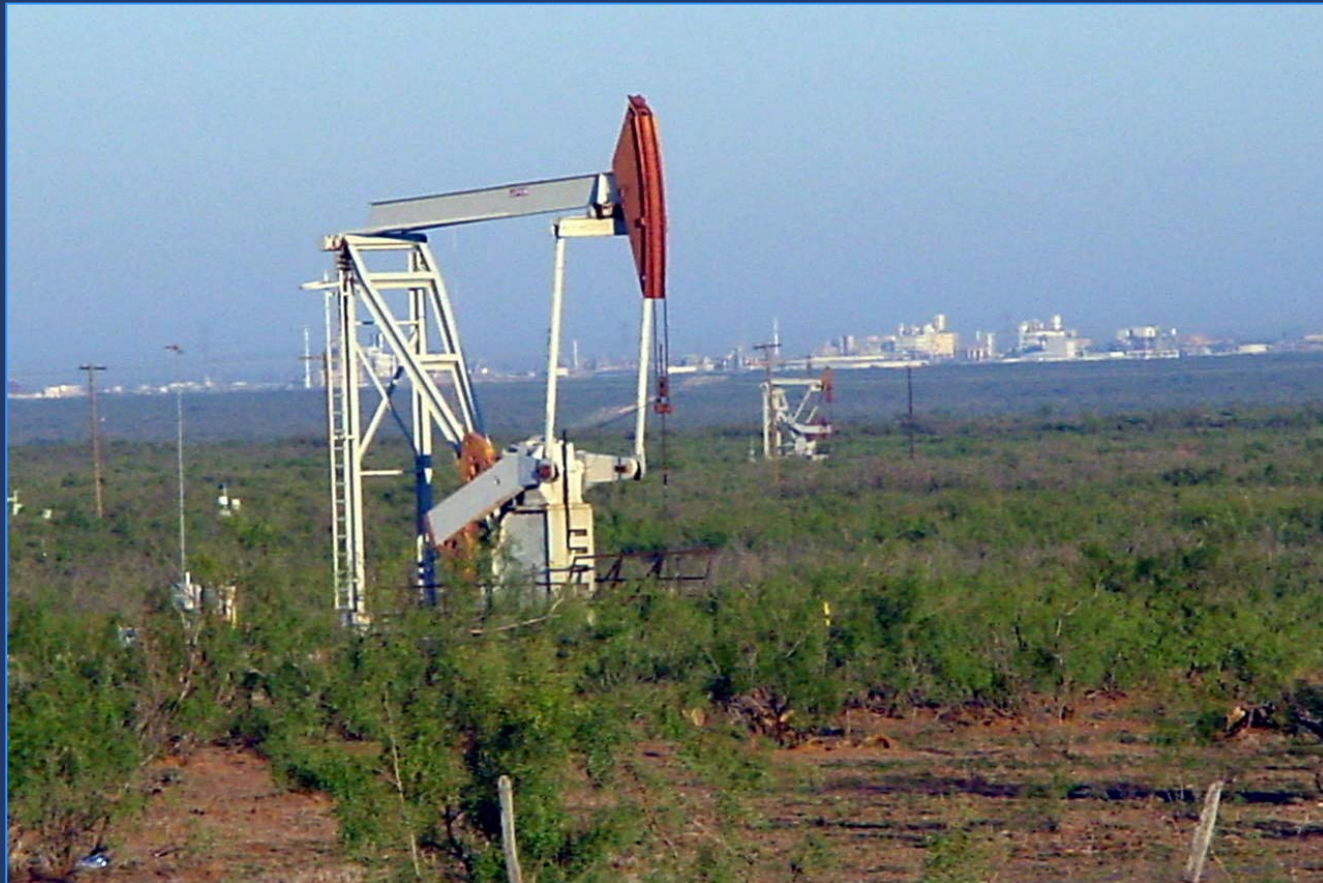

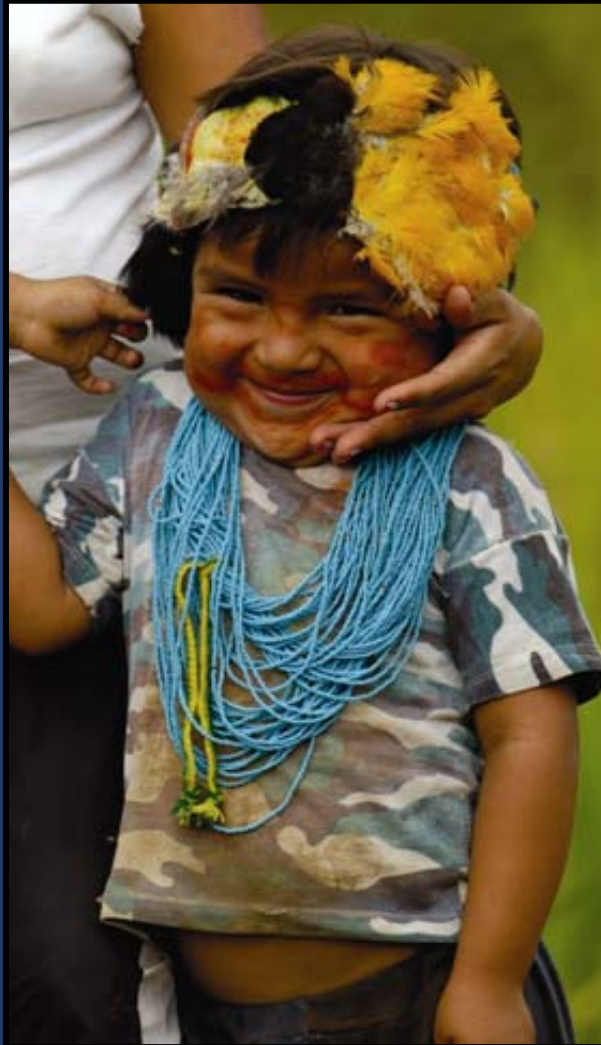
