## **NOTICE:**

The U.S. Environmental Protection Agency, Region III (EPA) plans to issue an Underground Injection Control (UIC) Class II-D permit to Seneca Resources Corporation (Seneca) for disposal of fluids from Seneca oil and gas operations. This action is being taken pursuant to the Federal UIC regulations at 40 C.F.R. Parts 124, 144, 146, and 147.

### **NEED and DESCRIPTION:**

Seneca submitted an application to operate a new UIC Class II disposal injection well permit, to be used for the injection of fluids produced in association with Seneca's oil and gas operations. The well (Well # 38282) is located in Highland Township, Elk County, Pennsylvania. The draft permit, when finalized, will allow Seneca to convert Well # 38282 into an injection well for produced fluids from Seneca's oil and gas operations, injecting into the Elk 3 Sand formation at depths between 2327 and 2372 feet.

### **OPPORTUNITY FOR COMMENT:**

EPA requests public comment on its findings that the proposed injection activity under the draft permit is protective of underground sources of drinking water. EPA expressly reserves the right not to hold a hearing unless a significant degree of public interest on the proposed permit is demonstrated by July 20, 2017.
