Children can be more affected by pollution than adults - they're smaller and their bodies are still developing. Children eat, breathe, and drink more relative to their body mass than adults do, increasing their exposure risk. Children crawl and play close to the ground often putting their hands, toys and other items into their mouths making them more likely to come into contact with dirt, dust, and toxins.

## Waters of the United States Rulemaking Outreach

EPA and the Department of the Army are proposing a rule to re-define the **Waters of the United States** under the Clean Water Act. The agencies will hold public meetings to hear from stakeholders on recommendations to revise the definition.

A teleconference for the general public will be held on **November 21** at 10:00 a.m. Pacific Time. It is one of ten teleconferences for various stakeholder groups. [Register online](#) for the listening session for the general public by **November 14**.

## Water Quality Standards Variance Building Tool

EPA's [Water Quality Standards Variance Building Tool](#) can help states, territories, and authorized tribes learn about Clean Water Act water quality standard variances and when best to apply them. The tool explains how WQS variances can provide water quality improvement opportunities before downgrading a water body's designated use.

The tool also allows users to draft sample language for a potential variance, which can be used to begin stakeholder discussions. States, territories, and authorized tribes are neither required to use the tool, nor does using the tool guarantee EPA approval of WQS. ## Alaska News

### Region 10 Tribal Operations Committee Seeks Alaska Nominations

**NOMINATIONS DUE: October 13.**

EPA is seeking nominations from federally recognized tribes in Alaska for two Region 10 Tribal Operations Committee positions, Alaska Position 1 and Alaska Position 2. The RTOC is a partnership between EPA and elected tribal representatives. The mission of the RTOC is to protect and improve tribal health and environmental conditions for federally recognized tribes consistent with EPA's Indian Policy, trust responsibility, environmental laws, policies, and guidance.

The RTOC holds up to four in-person meetings per year. Typically, these meetings are held in Seattle, WA, with one hosted by a tribe within Region 10. The RTOC also holds monthly conference calls and assigns workgroups and subcommittees for special tasks. The position offers an opportunity to affect EPA's relationships with tribes. Representation on the RTOC requires a significant time commitment in coordination with other tribes, and issue formation and discussion.

To be eligible for these RTOC positions, the nominee must be an elected tribal official or staff willing to serve a three-year term starting January 1, 2018. Tribes are encouraged to submit nominations by downloading and completing the online [RTOC Nomination Form](#). For more information on RTOC, see page X of this newsletter.

**Idaho NPDES Program Application**

PUBLIC COMMENT END DATE: **October 10.**

EPA Region 10 sent letters to all tribal governments in Idaho providing an update on EPA’s review of the Idaho National Pollutant Discharge Elimination System program application that was submitted in 2016. The letters notified tribes in Idaho about EPA’s public review process and invited tribal governments to initiate tribal consultation on EPA’s review and approval action. Last month, EPA held meetings with tribal leaders and staff in conjunction with public hearings in 5 Idaho cities.


The NPDES permit program addresses water pollution by regulating point sources that discharge pollutants to waters of the U.S. Created in 1972 by the Clean Water Act, EPA’s NPDES permit program authorizes state governments to perform many permitting, administrative, and enforcement aspects of the program.

## Tribal Consultation

### **Proposal to Withdraw Proposed Determination for Bristol Bay Pebble Deposit under Clean Water Act Section 404(c)**

END DATE: **October 17.**

The EPA is proposing to withdraw its July 2014 Clean Water Act Proposed Determination that would, if finalized, have imposed restrictions on the discharge of dredged or fill material associated with the potential Pebble Mine in Alaska's Bristol Bay watershed. EPA agreed to initiate a proposed withdrawal process pursuant to policy direction from EPA's Administrator, and as part of a [May 2017 settlement agreement](#) with the Pebble Limited Partnership, that resolved litigation from 2014.

EPA is consulting on the proposed withdrawal with federally recognized tribal governments of the Bristol Bay region and with Alaska Native Claims Settlement Act Regional and Village Corporations with lands in the Bristol Bay watershed. EPA published a [Federal Register](#) notice that initiated the withdrawal process.

The public comment and consultation period closes on **October 17.**

### **EPA's Draft FY 2018-2022 Strategic Plan**

END DATE: **October 31**

EPA is initiating consultation and coordination with federally recognized tribes on EPA's [Draft FY 2018-2022 Strategic Plan](#). The Plan communicates the Agency's priorities, the measurable environmental and human health outcomes the public can expect over the next four years, and the long term blueprint for achieving those results. It also serves as the basis for Agency-wide program planning, and informs annual budget development and decision making. The Plan covers important areas of interest that impact tribes.

Tribes may also participate in the public review and comment period that runs concurrent with the tribal consultation period. The final Plan will be issued to Congress in February 2018 along with the FY 2019 President's budget – both of which will be available on EPA's [Planning, Budget and Results](#) website.

There will be two national conference calls for tribes to discuss the Plan. Leadership from EPA's Office of the Chief Financial Officer and Office of International and Tribal Affairs will be present on both calls. The Tribal Consultation calls will be held **October 17** at 11:00 a.m. Pacific Time, and **October 24** at 11:00 a.m. Pacific Time. ## National Oceanic and Atmospheric Administration FY 2018 Marine Debris Removal Grants

APPLICATIONS DUE: **November 1.**

Projects awarded through this grant competition will create long-term, quantifiable ecological habitat improvements for NOAA trust resources through on-the-ground marine debris removal activities with priority for those targeting derelict fishing gear and other medium and large-scale debris. Projects should also foster awareness of the effects of marine debris to further the conservation of living marine resource habitats and contribute to the understanding of marine debris composition, distribution, and impacts.

Typical awards will range from \$50,000 to \$150,000. Funding for this grant competition comes through the NOAA Marine Debris Program as appropriations to the Office of Response and Restoration, National Ocean Service. Learn more on [NOAA's Marine Debris Program](#) website.

## 2017 School Bus Rebate Program



APPLICATION DEADLINE: **November 14.**

Need help paying for that new school bus or upgrade? EPA is offering an opportunity to receive up to \$20,000 per vehicle to replace older school buses, and up to \$6,000 per vehicle for retrofits. Older school buses without emission reduction retrofits emit significant amounts of harmful exhaust, so participating in this program will help improve the health of students and other members of your community.

Regional, state, or tribal agencies – including school districts and municipalities, or private entities that operate school buses under a contract with an aforementioned entity are eligible.

**Department of Homeland Security –  
Federal Emergency Management Agency Grants  
FY 2017 Flood Mitigation Assistance**

APPLICATIONS DUE: **November 14.**

The **Flood Mitigation Assistance** Program makes federal funds available to state, local and tribal governments to reduce or eliminate the risk of repetitive flood damage to buildings and structures insured under the National Flood Insurance Program. In FY 2017, the FMA Program will prioritize proposals that address community flood risk by setting aside \$70 million for this purpose.

Federal Emergency Management Agency will seek to fund two types of community flood mitigation activities.

1. Advance assistance for flood mitigation design and development of community flood mitigation projects and mitigation projects that address community flood risk for the purpose of reducing NFIP flood claim payments.
2. The remaining funding - at least \$90,000,000 - will be used for FMA technical assistance, mitigation planning, and mitigation projects reducing risk to severe repetitive loss and repetitive loss properties.

Applicants may submit a maximum of one advanced assistance and one community mitigation project sub-application.

**FY 2017 Pre-Disaster Mitigation**

APPLICATIONS DUE: **November 14.**

The Pre-Disaster Mitigation program makes federal funds available to state, local, and tribal governments to implement and sustain cost-effective measures designed to reduce the risk to individuals and property from natural hazards, while also reducing reliance on federal funding from future disasters.

FEMA will provide allocations of \$575,000 as required by the Stafford Act to states and territories, and a tribal set-aside of \$10 million for allocations up to \$575,000 for tribal governments to support overall mitigation planning and projects. The remaining PDM funds will be awarded on a competitive basis with a focus on multi-state/tribal mitigation initiatives.

## FY 2018 Brownfields Assessment and Cleanup Grants

DUE DATE: November 16.

EPA's Brownfields Program provides funds to empower states, communities, tribes, and nonprofits to prevent, inventory, assess, clean up, and reuse Brownfield sites. A brownfield is a property, the expansion, redevelopment, or reuse of which may be complicated by the presence or potential presence of a hazardous substance, pollutant, or contaminant.

Grants may be used to address sites contaminated by petroleum and hazardous substances, pollutants, or contaminants (including hazardous substances co-mingled with petroleum). Two separate EPA Brownfields funding opportunities are available.

Although federally recognized tribes of Alaska are not eligible for the competitive Brownfields funding (with the exception of the Metlakatla Indian Community), Alaskan tribes may work with other eligible entities in the application process. In addition to local governments, land clearance authorities, regional councils, etc., the Alaska Native Village and Regional Corporations are eligible entities to apply for the following competitive Brownfields opportunities.

### 1. Assessment Grants (funded over three years)

- **Community-wide or Site-Specific Applicants.** Applicants may apply for up to \$200,000 in hazardous substances funding or up to \$200,000 in petroleum funding.
- **Community-wide Applicants.** Applicants seeking **both** hazardous substances funding and petroleum funding may request a combined total up to \$300,000, but the request for hazardous substances funding or petroleum funding cannot exceed \$200,000 for any one individual type of grant funding. For example, an applicant may apply for \$200,000 in hazardous substances funding and \$100,000 in petroleum funding.
- **Assessment Coalition Applicants.** Applicants may request up to \$600,000 in hazardous substances funding and/or petroleum funding.

### 2. Cleanup Grants (funded over three years)

Applicants may request funding to address either a single Brownfield site or multiple Brownfield sites within each proposal. An applicant may request up to \$200,000 in each proposal. An applicant can submit up to three cleanup proposals.

## Mine Financial Assurance Training

The Mine Financial Assurance Training class hosted by the Nez-Perce Tribe and National Tribal Mining Workgroup is a free, two-day training with two levels of information concerning hardrock mine financial assurance.

Day 1 will provide an overview and update on current hardrock mine financial assurance principles and practice and is intended for regulators, scientists and engineers, and others to become familiar with the concept and means by which hardrock mine financial assurance is based, estimated, and administered.

Day 2 of the Mine Financial Assurance Training will provide a more in-depth review of the actual methods by which financial assurance costs are estimated in the U.S. using the Standard Reclamation Cost Estimator, Process Fluid Cost Estimator, Long-Term Monitoring and Maintenance and other spreadsheet models, and is intended for anyone who might review financial assurance cost estimates.

Assistance is provided by the U.S. Department of Energy Office of Indian Energy and its national laboratories, along with other partnering organizations, at no cost. Each request will be evaluated based on scope and available budget. Current projects funded by DOE grants receive priority.

- Policy and regulation.


