What Must Be Monitored for Each Landfill that Meets the Requirements of §98.460 and §98.461?

| <input type="checkbox"/> For each type of cover material (either organic cover, clay cover, sand cover, or other soil mixtures), determine the surface area (in square meters) at the start of the reporting year for the landfill sections that contain waste. | <input type="checkbox"/> | using a 60-day anaerobic biodegradation test or via the total and volatile solids measurements following Standard Method 2540G "Total, Fixed, and Volatile Solids in Solid and Semisolid Samples" |
