Submission Status	Submission History	Add an email link for the TRI Data Processing Center on the Submission History page for submission status inquiries.
Form Preparation	Various Pages	Incorporate an improved "Reports" column for viewing and downloading reports.
Form Preparation	Section 8.1-8.7	Display Section 8 calculation formulas for all TRI chemicals.
Form Preparation	My TRI Landing page	Add a "New Reporting Requirements" tile to the My TRI page, alerting users to ICR changes.
Form Preparation	Form Home	Add loading screens when creating Revisions, Withdrawals, or when Importing forms to improve the user experience.
Form Submission	Various Pages	Update the display format for Release Totals for better clarity.
Form Submission	Review Forms (previously Check For Errors)	Improve the process for canceling forms pending certification.
Form Validation	Various Pages	When exiting Error Navigation Mode, provide an option to return to standard form preparation mode.
Form Preparation	Help	Display the CDX Helpdesk hours of operation on the Help page.
Form Preparation	Section 8.10	Allow users to report source reduction activities as well as barriers to source reduction in the same form.

User Management	Pending Forms	Allow Certifying Officials to edit their CDX profile from the Pending Forms page.
Form Preparation	Section 6.2	Add a RCRA ID reference link to the Section 6.2 Off-site Transfer Location search.
Submission Status	Submission History	Add a Release Totals column to the Completed Submissions table.
Form Preparation	Various Pages	Add the facility name to the form while reporting.
Form Preparation	Lead Threshold Determination	Improve Lead Threshold Determination details for understanding Lead reporting thresholds.
Form Preparation	Section 8.1-8.7	Add an icon that points out Section 8 data that was populated via Prior Year Import.
Form Preparation	Form Home	Add additional direction and detail concerning changing the form type.
Submission Status	Submission History	Add an option to download all certified forms for a given reporting year on the Submission History page.
Form Submission	Review Forms (previously Check For Errors)	Inform Certifying Officials of unassigned forms that have passed the error check but are not in the pending state.
Form Preparation	Various Pages	Add an icon and information tooltip pointing out new reporting fields in TRI-MEweb.
Form Validation	Review Forms (previously Check For Errors)	Add a bulk XML download option for multiple draft forms.
Form Validation	Various Pages	Highlight any Possible Errors in the form with an icon while in Error Navigation Mode.
Form Validation	Error List	Save Possible Error and Data Quality Alert comments after re-checking forms for errors.
Facility Management	Not Reporting	Expand the Not Reporting tool functionality for prior years and the upcoming future reporting year.
Submission Status	Submission History	Display recon comments for information when the TRI Data Processing Center is awaiting facility response.
Form Submission	Pending Forms	Display a prompt with a link to sign up for SMS Verification in the event a user fails their secret questions during form certification.
Form Validation	Various Pages	Add a notification for results when an error check is performed from within a form.
Form Preparation	Form Home	Improve chemical qualifier text when adding forms.
Form Validation	Review Forms (previously Check For Errors)	Rename the "Check For Errors" page to "Review Forms" to be more encompassing of the functionality on the page.
