## The Drinking Water State Revolving Fund: Highlights and Updates

The [Drinking Water State Revolving Fund \(DWSRF\)](#) program is a federal/state partnership with a primary goal of public health protection for communities through grants—awarded to each state—that provide a permanent source of financing for drinking water infrastructure. The DWSRF program contains both infrastructure and non-infrastructure components. This presentation will provide a quick history of the DWSRF, briefly discuss the program's various components, and explain recent DWSRF changes resulting from the America's Water Infrastructure Act (AWIA) of 2018.

## EPA's Assistance for Small and Disadvantaged Communities Drinking Water Grant

The [Assistance for Small and Disadvantaged Communities Drinking Water Grant](#) assists public water systems in underserved, small and disadvantaged communities meet Safe Drinking Water Act requirements. The grant includes approximately \$42.8 million in funding for 2019. This presentation will discuss the grant purpose and eligibilities.
