These listing IDs were used in Ecology’s 2015 submittal of the Deschutes TMDLs to EPA. The bolded IDs indicate a change was made for the 2012 list. One exception are the two listing IDs in parentheses. These were in Ecology’s 2015 submittal, but they were not on the 2010 303(d) list at the time and were subsequently added to the 2012 303(d) list.

²This column displays updated listing IDs as represented in Ecology’s 2012 303(d) list, approved by EPA on July 22, 2016. A blank space indicates that no updates were made from the 2010 303(d) list. Many listing IDs were combined with, or rolled into, existing listing IDs for the 2012 303(d) list.

³The Unnamed Spring was incorrectly aggregated with Listing ID 48713 for the 2012 listing cycle. The correct listing ID is from the 2010 listing cycle, Listing ID 48923 (personal communication, Jeremy Reiman, 4/19/2019). Also, Ecology identified concerns with the quality of the data collected at the monitoring site (12DES13.4SPRING) and plans to correct the classification to Category 3 for the next listing cycle.
