- This quarter, the QIC voted to approve the outline and plan for the Strategic Data Action Plan (SDAP)

Strategic Data Action Plan (SDAP)

Developing a Plan for Greater Accessibility to EPA's Data and Information:

- The primary purpose of the Strategic Data Action Plan (SDAP) is to standardize and streamline the process of prioritizing and publishing high-value information for public consumption
- Over the last quarter EPA has taken the following actions in support of the SDAP:
 - Published an <u>outline of the SDAP</u> with anticipated products, milestones and dates
 - Published <u>Interim EPA Data.gov Guidance and Procedures</u> for use while SDAP v1.0 is developed

EPA Data News

Bringing More Data to the Public this Quarter:

- Continued to increase EPA's information available on Data.gov (now over 1800 datasets/tools/geodata)
 - Added a new raw dataset: the Integrated Risk Information System (IRIS)
 - Added 6 new tools, focusing primarily on providing enforcement/legal information:
 - Consent Decrees
 - Integrated Risk Information System (IRIS) Website
 - Civil Penalty Policies
 - EPA Administrative Law Judge Legal Documents
 - Title III List of Lists Data Tool
 - Local Emergency Planning Committee (LEPC) Data
 - Added 115 new geodata sets (including Ecoregion data and STORET information)
 - Toxic Release Inventory (TRI) datasets are widely used by many stakeholders, and now all current and historical TRI datasets are available; this quarter we:
 - Published new 2009 TRI data on Data.gov in conjunction with the 2009 National Analysis release to the general public
 - Published dynamic versions of historical TRI datasets (1987 to 2008) to complete easy access to data from all TRI data years

OpenGov Performance and Measures

Update:

- EPA continues to take an iterative approach in developing performance, measures and metrics to track the effectiveness of actions taken to support the Agency's strategic goals through use of OpenGov principles
- We established (or are establishing) quantitative metrics for each of our Flagship efforts
- We are in the process of identifying or developing qualitative measures with the Flagship teams and anticipate including them in our 2011/Q2 report



Employee Engagement

Update:

- Added social media "dos" and "don'ts" to the annual ethics training all EPA employees must complete
- Continue developing an Agency-wide resource for OpenGov education, engagement and outreach including:
 - OpenGov (with links to Federal and EPA resources)
 - A repository of best practices, benefits and lessons learned
- Began populating the OpenGov internal Wiki to capture various Community Engagement Flagship efforts
- Once sufficiently populated we will create an external view of Wiki content for transferability

Communications Strategy

Approach:

- The OpenGov workgroup is applying a Communications Framework that includes:
 - Using the internal Wiki to provide access to background information, updates and points of contact for questions on OpenGov
 - Quarterly progress reporting to provide accomplishments and project descriptions
 - Workgroup members share information within their organizations
 - Briefings to the QIC for direction, approval, and program commitments
 - Updates to OpenGov 101 briefing template for use by program representatives
 - Links to EPA's OpenGov page from key locations within EPA's intranet site
