

HFC Report Submission Calendar

The EPA has established timing requirements for reporting under the HFC Allocation Rule as outlined below.

Some reports follow a schedule with precise due dates that recur each Control Period. The Control Period covers one calendar year and is divided into three-month quarters. Entities may need to report activities and information from one or more quarters, depending on the report type. The quarters are organized as follows:

- 1st Quarter: January 1 – March 31
- 2nd Quarter: April 1 – June 30
- 3rd Quarter: July 1 – September 30
- 4th Quarter: October 1 – December 31

Some reports are not submitted according to the above calendar. Rather, their due dates depend on the type of report or timing of the activity being reported on. One-time reports and ad hoc reports fall under this category. See next page for additional deadlines.
