Funding Opportunities

Building Resilient Infrastructures and Communities Grant Announcement - Opens Sept 30th

The Federal Emergency Management Agency (FEMA) makes federal funds available through the new Building Resilient Infrastructures and Communities (BRIC) grant program to states, local communities, tribes and territories (SLTTs) for pre-disaster mitigation activities. FEMA has published a Notice of Funding Opportunity (NOFO) for the BRIC grant program. The Fiscal Year 2020 (FY20) BRIC NOFO can be accessed at www.Grants.gov. FEMA encourages reviewing the BRIC NOFO before applying, as it provides detailed program information and other grant application and administration requirements.

To apply for funding made available for FY20 through the BRIC program, Applicants must adhere to the following Application and funding deadlines:

- Application Opening: September 30, 2020
- Application Deadline: January 29, 2021 (3:00 p.m. Eastern Standard Time)

FEMA will offer webinars on the FY20 Notice of Funding Opportunities for prospective applicants and tribal applicants.

- Tuesday, August 25 at 2-3:30pm ET for prospective applicants
- Thursday, August 27 at 2-3:30pm ET for prospective tribal applicants.

NRCS: Regional Conservation Partnership Program (RCPP)

Grand Rapids was awarded \$8 million for their partnership and spoke about this opportunity during River Rally. The application period is now open and they are having a webinar on the program next week.

USDA has announced \$360 million in funding for the next round of Regional Conservation Partnership Program (RCPP) conservation projects. Project applications are now being accepted for locally driven, public-private partnerships that improve the nation's water quality (including drinking water sources), combat drought, enhance soil health, support wildlife habitat, and protect agricultural viability. Projects are eligible to receive between \$250,000 and \$10 million in RCPP funding that is expected to be leveraged with funding and in-kind contributions from partners that are equal or greater to the NRCS investment. Funding is open to private industry, non-government organizations, Indian tribes, state and local governments, water districts, universities, and more. RCPP funding is divided evenly among two

funding pools, one for Critical Conservation Areas (CCAs) and one for projects in a single state or across several states.

RCPP Classic Application Period Open through November 4, 2020.

Farmer to Farmer RFA

The EPA's Gulf of Mexico Division is pleased to announce the availability of a new Farmer to Farmer funding opportunity. An estimated \$10 million dollars will be used to fund innovative practices approaches within farming communities, measure the results of those practices, and identify how the practices will be incorporated into farming operations. The funding opportunity has been posted on EPA's Gulf of Mexico Divison website and should be posted on grants.gov shortly.
