How does EPA evaluate the benefits of the program. How do you evaluate the aq changes in TEJ communities?	Anonymous Attendee	For DERA, we calculate benefits on a project by project basis. DERA funds may only be used on vehicles and technologies that have been tested and verified or certified by the EPA to reduce diesel emissions. Therefore, the tons of pollution reduced over the lifetime of the vehicles can be calculated. Further, replacement projects require that the old polluting vehicles be destroyed. Depending on the scale of project, air quality benefits may or may not be measurable by ambient air monitoring.
The eligible list for the ARP rebates is quite short. It would be easy to directly contact each eligible school district. What are your outreach processes so far?	Heather Choi, CARB (she/her)	We've posted a national press release and worked with our Regional offices to amplify the message to communities and school districts, including through our website, listserv, newsletters, and forums like this one. In addition, school transportation associations provide outreach about the rebates as well.
I worked on this in CT, and we noticed that the schools themselves were not aware of the ability to apply, and in CT the buses are run by an outside contracted company. This posed a barrier to upgrading buses to EV's.	Anonymous Attendee	Hi, thank you very much for your important comment.

Alex Spataru	The ARP pilot program is limited to school buses. However, DERA's National grant program can target all kinds of diesel vehicles and equipment including transit buses.
Does DERA cover only the cost of replacing these buses? Are there any programs to cover or help to cover some of the costs of installing charging stations for new zero emissions buses?	Anonymous Attendee	live answered
The other barrier we found in CT was the issue of installing fast EV chargers for EV buses. Many bus contracts are awarded by lowest bidder- which would keep costs down vs focusing on health or even access issues. One suggestion on ways this could better connect to LMI and at risk communities is to set an equity lens which recongizes that LMI communities have no funds to leverage for the 65% match funds. Equity would set count metrics such as "expanded access to public school- example- providing access to pre K buses, or shortened ride times for POC kids attending magnet or choice schools." Charles Bryson	DERA and Ports Initiative programs don't have formal relationships with local health departments, but it's a very good suggestion to partner with local health departments to get the word out about our programs to the extent that's not already something our Regional offices are pursuing.

Mona Munroe- Younis (she/her/hers)	New diesel vehicles are significantly cleaner than their predecessors and can reduce emissions of some pollutants like PM by 90%. In some cases, there is no commercially available electric replacement and in other cases, fleets may not want to be early adopters. Kari Fulton	The rebate is issued once the new bus is delivered and the old bus is scrapped, and all required documentation has been provided. We currently operate the rebate program through reimbursement.
Alot of the current funding going to communities that are "not at risk". I see this outcome being related to more affluent communities having more supports for time to apply for funds, and who also have funds to leverage, and who also have supports on EJ rules and EPA programs. Many POC and vunerable areas of our nation do not have liasons to support their applications, cash matches, or data needed to complete the application and supports. Books are very much needed for k8 grade- where there is not enough simple clear non scary empowering information. That is what I see all across America, in my own work. Thank you for the response. Second question: Why is EPA allowing new LNG export terminals to receive permits for air and water pollution, when those terminals release an extraordinary amount of GHGs and the Gulf Coast is arguably one of the nation's most affected areas by climate injustice (because of increased hurricanes, sea level rise/land loss, and the prevalence of polluting industry)? The people most negatively impacted by climate change on the Gulf Coast are people of color and low income people. There is no climate justice on the Gulf Coast as of now. What is EPA doing about that?	naomi yoder (they/them), Healthy Gulf	Thank you for this question, it is something best addressed by air permitting offices in EPA Headquarters and in EPA Region 6. We will refer your question to those offices for response.
Naomi raises a huge priority for environmental justice communities: addressing cumulative burden where communities face multiple sources of pollution and permitting processes do not include cumulative impacts analysis - which needs to be a standard part of permitting. We are continuing to move forward on addressing cumulative impacts and as Matt noted, we are having these important conversations on a consistent basis.
Excellent points Naomi- Thank you! We must make intentional efforts to ensure we talk truth. Examples: all air is connected- all water is connected. Our actions, choices, plans, and outcomes are connected. Thus we must educate communities and take action at the same time. We are so proud that Region 5 EPA sent a letter to the Michigan Dept. of Environment, Great Lakes and Energy (EGLE) to ask for cumulative impacts analysis in an egregious environmental justice case and an alternative building site - a proposed permit for a new facility across the street from Flint's largest low-income public housing complex. We need the EPA to follow up on that public comment letter and hold EGLE's feet to the fire. The EGLE Air Quality Division is not taking the letter seriously. They want to check a box in its permitting process that they looked at EJSCREEN but not do anything with the data that EJSCREEN tells us - 85% of residents within a mile are Black and low-income. That should be raising flags, especially as autoimmune disorders are widespread in Flint as one of many legacies of the Flint water crisis. We already have significant health vulnerabilities that makes the cumulative burden of new and existing facilities especially egregious.
