(apologies, I meant to say disadvantaged communities, not communities with EJ issues).	Gaby Baeza-Castaneda	Hi Gaby, the terms we use to describe communities point back to what EJ is. Environmental justice (EJ) is the fair treatment and meaningful involvement of all people regardless of race, color, national origin, or income with respect to the development, implementation and enforcement of environmental laws, regulations and policies. Fair treatment means no group of people should bear a disproportionate share of the negative environmental consequences resulting from industrial, governmental and commercial operations or policies. Meaningful involvement means: People have an opportunity to participate in decisions about activities that may affect their environment and/or health; The public's contribution can influence the regulatory agency's decision; Community concerns will be considered in the decision making process; and Decision makers will seek out and facilitate the involvement of those potentially affected. As programs keep what EJ is, there a few terms that use to encompass all that I descibed above.
