Demand for Stipulated Penalties Pursuant to Administrative Order on Consent

Dear Mayor Roth:

The United States Environmental Protection Agency, Region 9 ("EPA") hereby demands payment from the County of Hawai'i ("County") of stipulated penalties in the amount of <u>\$28,500</u> for the County's failure to comply with the above-referenced Administrative Order on Consent ("AOC"). As detailed in EPA's August 17, 2021 notice of noncompliance, EPA determined that the County failed to fully comply with the requirements of Paragraph 29(f) of the AOC because the County's July 23, 2021 design package for the proposed Pāhala Wastewater Treatment Facility ("WWTF") had not been approved for construction by the Hawai'i Department of Health by the July 24, 2021 compliance deadline.¹

Pursuant to Paragraph 43 of the AOC, EPA is authorized to assess stipulated penalties for the County's failure to meet any requirement set forth in the AOC, including the requirement to complete design of the proposed Pāhala WWTF by July 24, 2021. Stipulated penalties accrue from the date performance is due and accrue at a rate of \$150 per day for the 1st to the 30th day of noncompliance, \$300 per day for the 31st to the 60th day of noncompliance, and \$500 per day for the 61st day and beyond. For this violation, EPA's stipulated penalty demand covers a 90-day period of noncompliance extending from July 24, 2021 through October 21, 2021. The stipulated penalties for each day of noncompliance during this 90-day period totals **\$28,500**. As provided by Paragraph 44 of the AOC, the stipulated penalty shall be paid within 30 days of receiving this letter. The County shall make the payment of the stipulated penalty in accordance with Paragraph 48 of the AOC.

EPA's demand for stipulated penalties and the County's payment of the stipulated penalties do not modify the AOC's terms or conditions and the AOC remains in effect. This penalty demand and payment of stipulated penalties also do not reflect an election by EPA to forgo any judicial remedies to

enforce the AOC and only cover ongoing violations of the AOC for the period specified in this demand letter.
