Our teachers, from early childhood through elementary and beyond, are the troopers who routinely must deal with behavioral disorders of increasing numbers of children in their classes. According to a good friend who has been teaching elementary for 40+ years, the impact is daunting and effects the whole classroom culture. We are loosing teachers because of those challenges and the paycales that rarely come close to adequate compensation and appreciation for the time and enery required. Numerous scientific studies have shown an association between fluoride exposure and lowered IQ and other neurodevelopmental disorders, including ADHD. It has been well documented that Blacks and other minorities are disproportionately harmed from fluoride exposure (dental fluorosis being the most visibly obvious harm, and which is only a visible symptom of fluoride toxicity). EPA is currently reconsidering the 2020 rule that loosened limitations on toxic water pollution from power plants. Is NEJAC involved in bringing an environmental justice framework to this important reconsideration, and how can members in affected communities uplift environmental justice concerns in this process? Cont'd . . . The EPA must shift the paradigm from adding toxic hazardous waste (fluorosilicic acid from phosphate fertilizer production) to public drinking water to help the CDC redirect pro-fluoridation efforts to more direct dental treatment programs where needed most, instead of continuing the promotion of mass medication to treat tooth decay. Fluoride is as toxic to in utero and early childhood brain development as lead. What will it take from the EPA to reverse the increasing incidence of classroom behavior issues that may be attributed to fluoride exposure? John Mueller	Hi John, we appreciate your comment. We cannot speak on behalf of the NEJAC and their capabilities, they are valuable group independent of the EPA. But with their upcoming meeting, I recommend submitting a comment to the NEJAC. I have done so, beginning with the inaugural WHEJAC public mtg on March 30, also NEJAC meetings in June, August, and two weeks ago. Since fluoridation is a national crisis, and the entire fluoridated US comprises an EJ community, can't this issue be addressed in these community calls? The CDC is responding - why not the EPA? Adding fluoride exposure is contributing to classroom "chemical brain drain." And it is clearly an EJ issue. Sweeping it under the rug in this meeting is quite simply more of the same, status quo.
