





Executive Order 13175 sets out considerations for consultation and coordination with federally recognized tribal governments.



"Waters of the United States" and the Clean Water Act

- Waters of the United States" (WOTUS) is a threshold term in the Clean Water Act that establishes the geographic scope of federal jurisdiction under the Act.
- Clean Water Act regulatory programs address "navigable waters," defined in the statute as "the waters of the United States, including the territorial seas."
- The Clean Water Act does not define WOTUS; Congress left further clarification to the agencies.




Previous "WOTUS" Definitions

- The EPA and the Department of the Army (Army) have defined WOTUS by regulation since the 1970s, including:
 - Pre-2015 Regulations and Practice
 - 2015 Clean Water Rule
 - 2020 Navigable Waters Protection Rule

Why WOTUS Matters

"Navigable Waters": Waters of the United States, including Territorial Seas



Definition of "Waters of the United States"

- Affects the extent to which CWA provides protection over waters for the listed programs
- Influences how states and authorized tribes for certain CWA programs can implement those programs
- May influence how states and tribes strategize for protecting their resources into the future—such as whether to pursue authorization for additional CWA programs
- Influences how EPA and the Corps will directly implement CWA programs on tribal lands in the absence of an authorized tribal program

Executive Order 13990 and "Waters of the United States"

- Executive Order on Protecting Public Health and the Environment and Restoring Science to Tackle the Climate Crisis (January 20, 2021)
- Directs agencies to review recent regulations, including the NWPR
- Identifies science, the environment, climate change, and environmental justice, among others, as issues to consider

Durable Definitions for WOTUS

Two new rulemakings

- Rule 1: Restore pre-2015 regulations, amended to be consistent with Supreme Court decisions
- Rule 2: Build upon that regulatory foundation with the benefit of additional stakeholder engagement

Process considerations

- Protecting water resources and our communities consistent with the Clean Water Act
- Considering the direction in the Executive Order
- Recognizing the importance of practical implementation
- Reflecting the experience of, and input received from, tribes, states, local governments, landowners, the agricultural community, community organizations, environmental groups, and communities with environmental justice concerns

Rule 1: Restoring a Foundation

- Pre-2015 regulations
- Updated for consistency with Supreme Court decisions

This is the proposed rule that is the subject of the tribal consultation and coordination process

"Waters of the United States" - 1986 Regulations

- (a)(1) Traditional navigable waters
- (a)(2) Interstate waters
- (a)(3) All "other waters" . . .
- (a)(4) Impoundments
- (a)(5) Tributaries of waters identified in (1)-(4)
- (a)(6) Territorial seas
- (a)(7) Adjacent wetlands

Identical language codified by EPA in 1988

Supreme Court Language

United States v. Riverside Bayview Homes (1985)

- The Court unanimously upheld the Corps' inclusion of "adjacent wetlands" in the regulatory definition of "waters of the United States."
- Solid Waste Agency of Northern Cook County v. U.S. Army Corps of Engineers (2001) (SWANCC)
 - The Court held, in a 5-4 decision, that the CWA does not confer jurisdiction over isolated waters on the sole basis that they provide habitat for migratory birds.

Supreme Court Language

Rapanos v. United States (2006)

The Justices were divided in a 4-1-4 opinion on the question of CWA jurisdiction over wetlands adjacent to nonnavigable tributaries of traditional navigable waters

Scalia Plurality Opinion

- "relatively permanent, standing or continuously flowing bodies of water"
- wetlands with a "continuous surface connection" to such waterbodies

Kennedy Concurring Opinion

• "a water or wetland must possess a 'significant nexus' to waters that are or were navigable in fact or that could reasonably be so made"

Dissent

 deferred to the Corps' exercise of jurisdiction and concluded that the term "waters of the United States" encompasses all tributaries and wetlands that satisfy "either the plurality's [standard] or Justice Kennedy's"
