As you know, Francis Menton and I represent the Concerned Household Electricity Consumers Council (CHECC). On their behalf we have filed an administrative petition for reconsideration of the 2009 Endangerment Finding for Greenhouse Gases, and so far have supplemented it three times when new relevant information became available.

On October 17, 2017, we last supplemented our petition with a letter from 64 distinguished scientists. Please see:


