Hello Sir/Madam my name is [REDACTED] And I am currently incarcerated at [REDACTED] The William G. McConnell Unit in Beeville, Tx and I am writing your office because I have a few questions about some hazardous and unhealthy living conditions that us inmates are currently living in that jeopardizes our lives and well-being in this penal institution and the Administration is fully aware that these problems exist and refuse to correct them! The Two(2) issues have no due with faulty plumbing which causes use to drink sewage drinking water and sewage line vents which are inoperable causing us to inhale sewage gasses 24 hours a day because the vent pipes are corroded in their entirety and not function as they should to dispell sewage gasses into the air outside of our living units. Due to the presence of raw sewage seeping into the drinking water source inmates are contracting bacterial infections, namely: *Escherichia coli* is acquired by drinking contaminated water or food and can be passed person to person and is associated with stomach cancer, ulcers, and tumors. 
