Dear Ms. Golightly-Howell:

I have not heard from Ms. Covington as of today. I am writing to say that I am deeply disturbed that pro fluoride posters are being displayed in the Senate Russell Building rotunda without any notification to the public of the risks. There is no warning to already admitted overdosed minorities that whole body fluoride dosing through municipal water supplies is NOT in their best interest. This is evident by documented high rate of dental fluorosis of minorities which is a biological indicator of over exposure to ingested fluoride. This is unethical, lacking in scientific integrity, and highly discriminatory that these posters would not come with a disclosure.

I had inquired with my Senator Isakson's staff as to who authorized the Russell Building display and gave permission to take part in this discrimination. I have not been given any answer as of today. Senator Isakson's staff investigated and reported to me this summer that no federal agency has jurisdiction over fluoride. This is contrary to what the legal departments of both the HHS/EPA interpret of Congress and declare to the public in high level meetings I have engaged with them. Both accuse the other of jurisdiction while teaming together to promote fluoridation, but neither advises/discloses to the public the known risks/weight of scientific evidence. I am providing a photo below of the Russell Building rotunda discriminatory display.

Additionally, because of The Center for Public Integrity Kristen Lombardi's recent investigative series on EPA OCR complaints, I am requesting that EPA Region IV former Acting Regional Administrator, A. Stanley Meiburg, respond with follow up information about the Environmental Justice meeting on Tuesday, October 27, 2009, that Dr. Robert Bullard organized with him. This meeting included representation from 29 communities in Region IV who like myself may have filed OCR complaints following the meeting, but did not receive proper attention. As my concerns have indicated, there is a potential systemic falsification of Region IV confidential hazardous scoring sheets which was the case of my former residency. These predominantly minority communities who met with Mr. Meiburg should now be given full review to any OCR complaints filed. If hazardous scoring sheets were falsified on them also like my former residency, this needs to be fully investigated.

Furthermore, I am requesting also that Administrator McCarthy re-open investigations into communities represented at Dr. Bullard's meeting in 2009 if there is any justifiable reason to do so like the Pittard Road community in Athens, GA who continue to have young residents to die of cancer. The Pittard Road Community was never informed of the hazards from DuPont/InVista which EPA secretly negotiated in 2009 with a historical consent/settlement although a local/state investigation took place just prior to the consent. It has also been uncovered by GA Open Records since the meeting with Mr. Meiburg that the Dunlap Road Community plagued by the government owned/operated MSWL was not given full disclosure of the hazardous risks known to be occurring to them as well. Both of these black communities were switched to fluoridated municipal water supplies without being informed of the whole body fluoride dosing risks to them.

I asked last week that you date my complaint as Oct 30, 2015 because I was still waiting on FOIA material that I have not received. I have not been notified when I will receive these materials (and it has been many months on some) so I am copying the FOIA reps who were assigned to my requests.
