in this huge region that is so desperately

poor and affected by air pollution

870

as we're the dirtiest air base in the nation

even surpassing Los Angeles many years

871

01:10:50,719 --> 01:10:58,560

but I'm more interested in- at this point

our work around climate and our communities

872

01:10:58,560 --> 01:11:05,280

and specifically what we're

seeing in terms of investment in

873

01:11:05,280 --> 01:11:12,908

and infrastructure in these communities to

ensure that our residents aren't left behind

874

01:11:12,932 --> 01:11:19,920

in this rush to this new zero

net carbon, zero net energy future.

875

It would be great to have a tool like the EJ tool that you've created

876

which you pointed out the gaps in it

but I've watched it get better

and better over the years

and quite honestly other than CalEnviroscreen,

there's not much else out there,

so it always adds to the conversation at

least while not taking away from it

probably generations of investment

make them energy efficient and seal them up

maybe get a used EV in the driveway
