on the (b) (6) - Privacy unit in Walker County, Huntsville, Texas.

"Yes" we have tried on numerous occasions to bring this issue to the  
Administration and Grievance Section Attention as well as the Regional  
Office in Downtown Huntsville Texas, in which they all either do not  
respond back or claim that there is nothing wrong with the water, but  
to many inmates are getting sick, including my self. So enclosed here in is  
the evidence from the water faucet in my cell to prove that there is  
something wrong with the water here, but if there isn't there is  
nothing wrong with being 100% sure. The officer don't drink it they are  
given bottled water around the clock, yet 1600 men (inmate) drink  
water daily. Reasons complaints inmate has been having excruciating  
stomach cramps and serious head aches upon which the inadequate  
medical department and these doctors and nurses don't drink the water,  
but tells us inmates that nothing is wrong with it but prescribe  
(b) (6) - Privacy for 7 years claiming it's acid reflux when I get to this  
unit people was dying from some un-told sickness with their stomach all  
swollen. We believe it's from the water, and there were also  
times when the water would get so "DARK" and "Smelly" to where we  
the (inmates) would go two-three days without water, drinking  
sodas only, because bottled water would only be passed out to  
officers. Also the water give your breath a horrible smell and bad  
taste. That's why in the (b) (6) - Privacy case the water needs proper  
testing of the water. I am humbly asking that one or more  
agencies conduct an investigation into this matter and put  
a stop to this 8th Amendment Violation. THE CONSUMPTION  
OF HAZARDOUS WATER WERE A VIOLATION OF THE U.S. CONSTITUTION.

The following matter if properly investigated will prove the validity of the issue claimed "pertaining to the quality of the drinking water being consumed here on the (b) (6) - Privacy unit. Also The (b) (6) - Privacy unit has the highest number of stomach Aches, Stomach cancer, Kidney, Lung Cancer, Liver and gall Bladder problems in this region.

Inmate here are having Cramps, muscle Aches, Tumors and dietic spazoms, and weakness and tiredness in mass numbers. These are clear signs of Lead or at least we inmates do believe so.

I've Done my part I told you, now its up to your office before we have more sick or Dead inmates here on (b) (6) - Privacy unit.
