WOULD LIKE TO FILE A CIVIL RIGHT COMPLAINT AGAINST ONE OF THE EPA-ECRCO GRANTEES: **THE CNMI-OFFICE OF PLANNING AND DEVELOPMENT/ CNMI-OFFICE OF THE GOVERNOR-** [REDACTED] **PLANNING@OPD.GOV.MP:**

THIS COMPLAINT IS ALONG THE LINES OF:RETALIATION, COLOR /NATIONALITY DISCRIMINATION, AND VIEWPOINT DISCRIMINATION:BECAUSE I ALSO HAVE 3 OTHER FEDERAL COMPLAINTS AGAINST THIS GOVERNMENT: 1# FEMA-CIVIL RIGHTS, SBA-TITLE 7, CIVIL RIGHTS, AND U.S.DEPT OF INTERIOR.

TODAY, DURING THE SSG-ONLINE CLASS, I SIMPLY ASKED WHY," I'M NOT ALLOWED TO GET FREE LUNCH, THOUGH I HAVE BEEN ACTIVE THROUGHOUT THE SESSION; AND I WAS TOLD THAT THE SESSION WAS FULL, AND THAT THERE WAS NO MORE SEATS; YET DURING TODAY'S SESSION- I NOTICED THAT THERE WERE MANY 25-30 PEOPLE INCLUDED IN THE PHYSICAL; MEETING;

THUS, I TEXTED..WHY ARE THEY ALLOWED TO GET FREE LUNCH WHEN THEY ARE NOT PARTICIPATING-,MEANING ANSWERING QUESTIONS, NOR ANYTHING...JUST SITTING IN THE SEAT AWAITING THE FREE LUNCH.

THE MODERATOR TOLD ME THAT I COULDN'T BRING SUCH SUBJECTS UP. AND WARNED ME.. FOR WHAT? WHY ARE YOU WARNING ME FOR ASKING AN OBVIOUS QUESTION?

THEN SHE TOLD ME THAT THIS WAS MY FINAL WARNING...SO, I ASKED IF I COULD COME THERE FOR FREE LUNCH..SHE TOLD ME THAT SHE WOULD BLOCK ME.. FOR WHAT?

EVERYONE KNOWS THAT I AM THE ONLY BLACK PERSON IN THE CLASS MINUS [REDACTED] AN EMPLOYEE OF FEMA.

SO, I SENT THIS ERIN LADY A DM TEXT: BASICALLY STATING THAT THE CNMI-IRP IS ALREADY UNDER INVESTIGATION FOR DISCRIMINATING AGAINST ME, AND THAT SHE SHOULDN'T GET INVOLVED..

THEN, A FEW MINUTES LATER I WAS KICKED OUT OF THE ONLINE CLASS..

THIS IS RETALIATION; BECAUSE EVERYONE IN THE CLASS- KNEW THAT I HAVE FILED CHARGES AGAINST THE CNMI GOVERNMENT FOR DISCRIMINATION AGAINST ME FOR STANDING UP FOR THE AMERICAN WORKERS HERE..AND FOR EXPOSING CORRUPTION.. I'D LIKE THIS INVESTIGATED..BECAUSE NOW I HAVE LOST 2-3 DAYS OF INVESTMENT IN TIME AND MONEY..

JUST TO BE BLOCKED FROM A PROGRAM IN WHICH I AM EXERCISING MY 1ST AMENDMENT RIGHTS,HAVE NOT BEEN DISRUPTIVE BY ANY MEANS, AND FOR ASKING THE SIMPLE QUESTION: WHY ARE YOU ALLOWING THESE PEOPLE TO EAT FREE..WHEN THEY AREN'T PARTICIPATING...

THE EPA CANNOT ALLOW THE CNMI TO MISUSED FEDERAL FUNDING TO PICK AND CHOOSE WHO GETS SERVICES AND WHO DOES NOT DUE TO THEIR COLOR AND SEXUALITY OR POLITICAL OPINIONS.
