There are 3 uranium mines right next to the women's prison in Lusk Wyoming. It is the ONLY women's prison in Wyoming with about 200 inmates here the total population of the town was 1500 now it is 700 or less including the inmate population. It is my understanding that the Feds issued mandates that the people here were not to drink the water here as this town is basically designated as a hazardous waste site, toxic dump, which poses significant risks to the safety, health and lives of the women here who are to be safe in the care, custody + control of WDOC Staff + Contractors. My 8th Amendment Civil + Constitutional

have been violated, prejudiced, deprived and abridged by my placement at this facility when I am a Fia DOC Inmate housed at the Wyoming Women's Center involuntarily after I reported 2 male Fia DOC Staff drugging + raping an inmate under the PREA - Prison Rape Elimination Act. The State of Fia sent me to Wyoming as retaliation and did not tell my family or myself that this prison + the entire town has had numerous toxic water issues with multiple Federal EPA warnings about the toxicity of this town. The State of Wyoming should have shut this facility down many years ago. Women are ill here with cancer + major skin issues and the Staff here is doing nothing to help them. Also this facility + the State of Wyoming receives Federal Funds from the Justice Assistance Grants with the US Dept of Justice that need to be stopped due to the Civil + Constitutional Rights Violations at this facility of 200+ women. I am also filing complaints with the US Atty Merrick Garland + US Atty Michael C Alston with the Office of Civil Rights for the

Per US Code Section 551+552 of USC
5 I am requesting per the FOIA,
Freedom of Information Act info on
ANY documentation that you may have
in your files on Toxic waste, pollution,
poor air quality, poor water quality
pollution control + prevention pertaining
to the uranium mines at/inusk within
the last 30 years. This includes mineral +
geology reports, files, records, assessments,
etc; complaints filed by Wy Tax Payers +
environmental groups; and any and all
further documentation within your Agency's
purview. Per the FOIA, I will expect a
reply within 10 days.

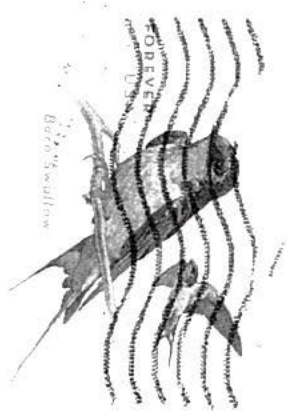
