

EPA Region 4 EQuIS Quick Start Guide

The Superfund Program in EPA Region 4 uses EQuIS 7 Enterprise to provide access to their environmental sampling data. This guide provides a summary of important documents for environmental data submission and a brief overview of how to access the EPA Region 4 Enterprise site.

Important Documents

The Environmental Data Submission procedural (SEMDPROC-009-R0) outlines how to prepare and submit EQuIS EDDs for EPA Region 4 and includes the following supporting reference documents:

- *EPA Region 4 EDD Format File Guide* Provides detailed information for the creation of the EDD files that are required to be submitted.
- *EPA Region 4 EQuIS Data Processor Reference Manual* Provides the information needed to download, install, and maintain the EDP software, as well as how to use the software to proof EDDs and create data packages.

EQuIS Stand-Alone EDP and the EPAR4 Format

EPA Region 4 has upgraded to EQuIS 7. All users should obtain the latest version of EDP 7 and the EPAR4 format file needed to submit data directly to the system.

- Obtain the EDP software, format file, and controlled reference values at: <u>earthsoft.com/products/edp/edp-format-for-epar4/</u>
- Follow the EDP Reference Manual on how to install and register the EDP data checker for EPAR4.
- The Approval Code to obtain the software license keys is: EPAR4-SESD-8617-2008-1

EQuIS Enterprise

To submit data to the EPA Region 4 EQuIS database, an EQUIS user account must be created. The following steps describe the account creation process.

- 1. Go to https://epar4.equisonline.com to open the login page.
- 2. Select the **Create New Account** link to open a New User Registration window.



a. Create your Username as:

f. One you have created your new user account, email <u>R4DART@EPA.GOV</u> with the site(s) for which you will be responsible to submit/view data. Your account will be manually activated, therefore there may be a delay in your account request and access approval.
