Brownfield Grant Funding Opportunities

The fiscal year (FY) 2023 Brownfields Assessment, Revolving Loan Fund (RLF), Multipurpose, and Cleanup Grant Guidelines are now available in www.grants.gov and on the EPA MARC Grant Application Resources webpage, along with other General Program Resources.

The application submission deadline is **November 22, 2022**.

More Grants!

The Bipartisan Infrastructure Law signed in November of 2021 brought significant increases in brownfields grants funding. Because of the breadth of this law – funding over 350 programs across more than a dozen federal departments and agencies – it contains other grants that complement brownfields grants. Targeted Brownfield Assessments

A Targeted Brownfields Assessment (TBA) is an investigation conducted by EPA contractors to document environmental conditions at a property that is being considered for redevelopment or reuse. TBAs are provided at no cost to communities, and applications are accepted and assessments performed on an ongoing basis throughout the year. You can get details and apply here.

Around The Region

<u>Groundwork Denver</u>, a nonprofit focused on partnering with youth and community to build a healthy, equitable, and sustainable environment, celebrated the graduation of their first cohort in July under their Brownfields Job Training Grant. The trainings offered in their first program included OSHA 10, HAZWOPER 40-Hour, Building Science Principles, Tree Care Industry Association Intro to Arboriculture, Rain Garden Installer, and Stormwater Control Measure Inspection and Maintenance. In Fort Yates, North Dakota on the Standing Rock Reservation, a TBA sampling event was held for a PhaseII environmental assessment. Inorder to sample soils below the existing underground storage tanks, two 10,000-gallon tanks were removed. Subsequent field testing results did not reveal soil contamination. The former gas station site had been vacant for over 20 years due to environmental concerns related to the underground storage tanks.

In June, Regional Administrator K.C. Becker toured brownfields and engaged with community partners in Cañon City and Pueblo, Colorado.



For more than a century, several large businesses and industries have blocked access to the Arkansas River in Cañon City (shown above left). Over time some have closed, leaving abandoned and contaminated buildings and properties. In 2021 Cañon City was awarded an \$800,000 brownfields multipurpose grant. A key focus is to assess and remediate industrial riverfront properties so that they can be relocated to allow for a new riverfront hospitality district which connects to the historic downtown.

In Pueblo, a \$300,000 brownfields assessment grant will build upon several past TBAs to launch a more comprehensive brownfields redevelopment program. The City has assembled a robust capital stack to encourage redevelopment, and this assessment grant is an important first step. One example of a potentially transformative redevelopment is the Pueblo Power Plant at the Black Hills Energy site (in photo above right).

Congratulations to Kalispell! The Parkline Trial, now the gem of the Core Area, opened in July of 2022. Since 2009, EPA brownfields grants and technical assistance have supported this rail-to-trails redevelopment and the revitalization of the downtown core.

Kalispell, Montana was built by the Great Northern Railroad in 1892. Over the decades, the town grew around and became bisected by the rail line, resulting in serious safety and mobility issues. As the demand for rail service diminished, the tracks, associated structures, potential contamination and safety issues remained.

Kalispell's approach to correct this situation began with an EPA Brownfields Area-Wide Planning grant that supported intensive community engagement. (The Core Area consists of roughly 1,100 parcels and 450 property owners.) The resulting Core Area Plan both developed a vision for the future and recognized the brownfields work required to begin the journey.
