**Re: Referral of Administrative Complaint**

Dear Mr. Rosenbaum:

The U.S. Environmental Protection Agency (EPA), Office of External Civil Rights Compliance (OECRC) is referring the referenced complaint, which was received August 23, 2022 and submitted by (b)(6) Privacy, (b)(7)(C) Ent. Privacy on behalf of various individuals incarcerated at the Caddo Correctional Center D/SEG in Shreveport, Louisiana (Caddo). The complaint alleges that conditions and practices at Caddo violate the individuals' rights under the First, Sixth, Eighth and Fourteenth Amendments of the United States Constitution.

As this complaint does not fall within the OECRC's jurisdiction, OECRC must reject the complaint and close it as the date of this letter. Because the U.S. Department of Justice (DOJ) may have jurisdiction over Caddo, OECRC is referring this complaint to your office for appropriate action. We have notified the complainant that we are forwarding the complaint to DOJ and provided your contact information to complainant. A copy of our rejection letter as well as the complaint are enclosed.
