
**AMENDMENT TO ADMINISTRATIVE  
ORDER FOR COMPLIANCE**

Property located northeast of Jefferson )  
Avenue, south of )  
Industrial Park Drive, and north of Kings )  
Ridge Drive, Newport News, Virginia )

1. On May 2, 2000, EPA Region III issued to Respondents an Administrative Order for Compliance ("AO") with respect to certain property known as the J. Denbigh Site, located in Chesapeake, Virginia, as more fully described in the AO (the "J. Denbigh Site").
2. The AO issued to Respondents was one of several AOs issued simultaneously to, *inter alia*, protect wetlands located at several sites in eastern Virginia. Upon information and belief, activity at one or more of those sites may have continued that will or may result in further unauthorized discharges into wetlands. To the extent that illegal discharges are or may be occurring at the J. Denbigh Site, Respondents are hereby ORDERED to immediately cease and desist from all activity at the J. Denbigh Site other than in full compliance with applicable, duly-issued federal permits(s).
3. This Amendment is an addition to the provisions and requirements of the AO, and those requirements remain in full force and effect.


The effective date of this Amendment shall be the date it is received by Respondents.


