RE: Informal Resolution/Tolling of Preliminary Findings Timeframe

Dear Acting Commissioner Moran:

This letter concerns EPA Complaint No. 01R-22-R1, which was accepted for investigation against the Massachusetts Department of Environmental Protection (MassDEP) on December 5, 2022. The Office of External Civil Rights Compliance (OECRC)¹ is required by regulation to seek cooperation with Recipients in securing compliance with 40 C.F.R. Parts 5 and 7 through informal and voluntary means.² OECRC representatives described the process of developing and executing an Informal Resolution Agreement (IRA) to MassDEP's General Counsel on December 13, 2022. On December 19, 2022, MassDEP's General Counsel informed OECRC that MassDEP agrees to engage in negotiations toward the execution of an IRA. Subsequently, OECRC received a formal correspondence from Commissioner Martin Suuberg on December 30, 2022, affirming MassDEP's agreement to initiate the IRA process. OECRC, therefore, has suspended its 180-day timeframe for issuing Preliminary Findings (40 C.F.R. § 7.115(c)(1)) for the duration of the IRA process. OECRC will ensure that this process occurs without undue delay.

The goal of the IRA negotiation process is to reach an agreement between MassDEP and OECRC that resolves the issues accepted for investigation. If MassDEP and OECRC fail to reach an informal resolution agreement, OECRC will notify you and the Complainant of that fact and resume the process for issuing preliminary findings.³ To facilitate the informal resolution

On September 24, 2022, EPA announced the establishment of the Office of Environmental Justice and External Civil Rights (OEJECR) into which ECRCO was reorganized and renamed the Office of External Civil Rights Compliance (OECRC). OECRC continues to enforce and ensure compliance with federal civil rights laws which prohibit discrimination by applicants for and recipients of federal financial assistance from EPA.

agreement process, we will continue to engage with MassDEP, as well as the Complainant, to gather the necessary facts and information, including requesting your assistance in accessing pertinent records, arranging interviews of witnesses. Engagement during the IRA negotiation process may also include EPA facilitated meetings between MassDEP and the complainant.
