RE: Notice of Intent to Sue for Failure to Timely Grant or Deny a Petition to Object to Proposed Title V Permit No. 24-009-0021 for Cove Point LNG, L.P.'s Cove Point Liquefied Natural Gas Terminal

Dear Administrator Regan,

Pursuant to 42 U.S.C. § 7604(b)(2) of the Clean Air Act, the Environmental Integrity Project and Chesapeake Climate Action Network (collectively, "Petitioners") are writing to provide you with Petitioners' notice of intent to file suit against you in your official capacity as Administrator of the U.S. Environmental Protection Agency for failure to timely respond to our October 28, 2022 petition to object to the proposed Title V Permit No. 24-009-0021 ("Proposed Permit" or "Permit") issued by the Maryland Department of Environmental ("MDE") on September 15, 2022 to the Cove Point LNG Terminal ("Terminal") owned and operated by Cove Point LNG, L.P., ("Cove Point") in Calvert County, Maryland. Petitioners' October 28, 2022 petition to object is included with this notice letter (excluding the petition's attachments). See Attachment A.²

Authority to Bring Suit

Section 304(a)(2) of the Clean Air Act provides that "any person may commence a civil action on his own behalf" against the EPA Administrator "where there is alleged a failure of the Administrator to perform any act or duty under this chapter which is not discretionary with the Administrator." 42 U.S.C. § 7604(a)(2). The district courts have jurisdiction over these suits. 42 U.S.C. § 7604(a). Title V of the Clean Air Act imposes a nondiscretionary duty upon the Administrator to grant or deny a timely petition to object to the issuance of a federal operating permit on the basis that it is not in compliance with the requirements of the Clean Air Act, including the requirements of any applicable State implementation plan. 42 U.S.C. § 7661d(b)(2) ("The Administrator shall grant or deny such petition within 60 days after the petition is filed" and "shall issue an objection within such period if the petitioner demonstrates to the Administrator that the permit is not in compliance with the requirements" of the Clean Air Act).

Relief Requested

Pursuant to 42 U.S.C. § 7661d(b)(2), the deadline for the Administrator's response to the October 28, 2022 petition was December 27, 2022. As Petitioners have yet to receive a response from EPA to their petition, EPA has failed to respond to the petition within 60 days as required by 42 U.S.C. § 7661d(b)(2). In accordance with § 7604(b)(2), this letter serves to notify you that upon the expiration of the 60-day period after the postmarked date of this letter, Petitioners intend to file suit in a federal district court requesting the following relief:

- An order compelling you to grant or deny the petition within 60 days (or less) from the date of the court's order;
- Petitioners' costs of litigation, including attorneys' fees, filing fees, and other reasonable litigation costs; and
- Any other relief as may be just or appropriate.
