Screening levels were modified on March 16, 2023 to reflect updated operation procedures on when to apply mitigation methods to reduce dust. Action levels set by health departments have not changed.

mg/m<sup>3</sup> - milligrams per cubic meter

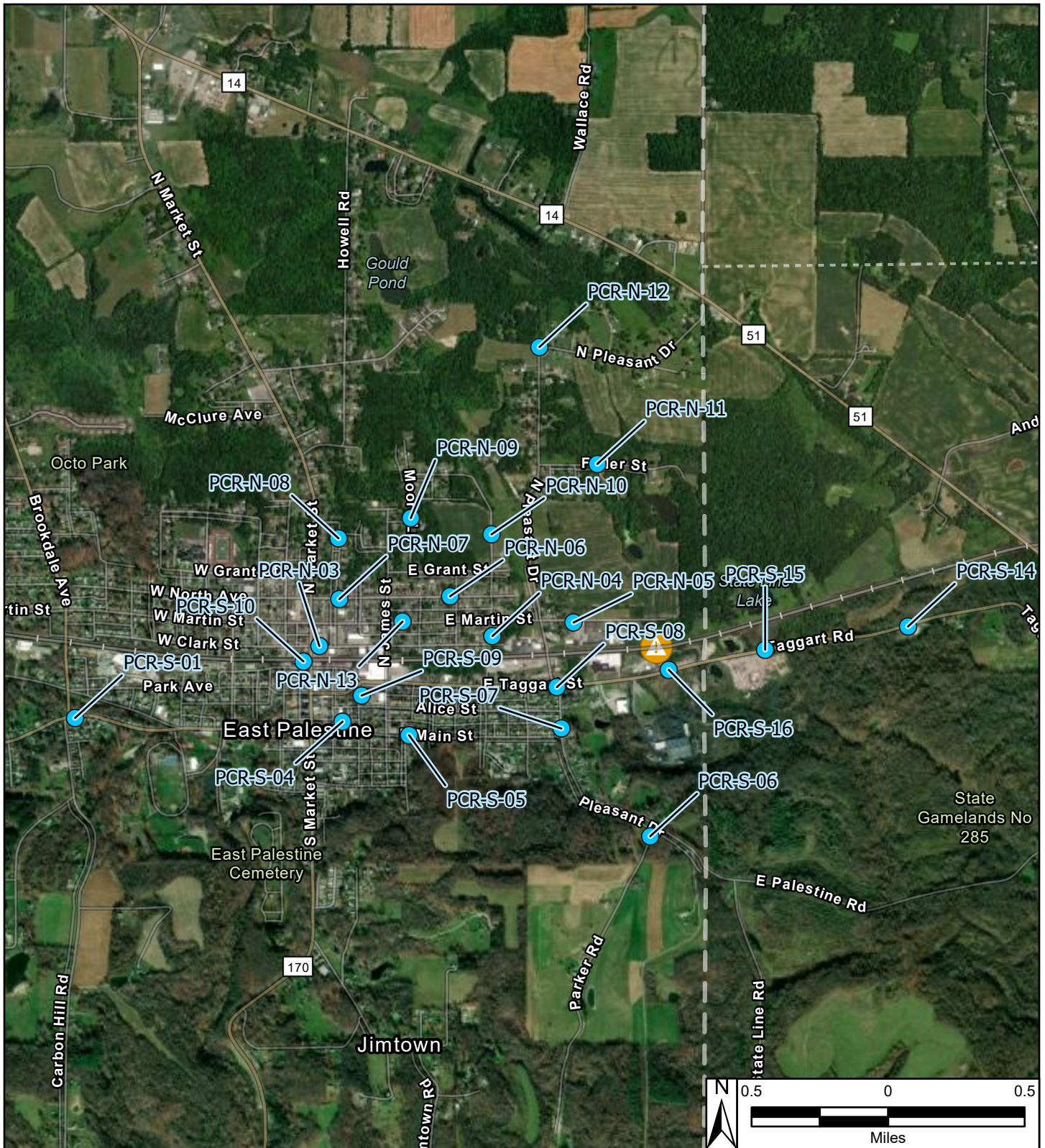
