Re: Referral of Administrative Complaint of Discrimination

Dear Regional Director:

The U.S. Environmental Protection Agency (EPA), Office of Environmental Justice & External Civil Rights Compliance, Office of External Civil Rights Compliance (OECRC),¹ received a complaint on May 17, 2023, from ^{(b)(f) (FIVACY, (b)(7)(G) EIIL FIVACY} The complaint alleges that the Michigan Department of Education (MDE) discriminates on the basis of race and that MDE personnel intimidated complainant, interfering with complainant's attempt to request services for Black and minority students.

OECRC has completed the jurisdictional review of the complaint. OECRC is rejecting the complaint for lack of jurisdiction because MDE is not a recipient of EPA financial assistance. OECRC's research reveals that MDE is a recipient of financial assistance; therefore, OECRC is referring the complaint to the United States Department of Education (ED) for appropriate action.

OECRC has simultaneously notified Complainant and MDE that these complaints have been forwarded to your office and provided them your contact information. The complaint, as well as EPA's rejection and referral letter, are attached.

¹ On September 24, 2022, EPA announced the establishment of the Office of Environmental Justice and External Civil Rights (OEJECR). The new Office includes the External Civil Rights Compliance Office, which was renamed the Office of External Civil Rights Compliance (OECRC). OECRC continues to enforce and ensure compliance with federal civil rights laws, which prohibit discrimination by applicants for and recipients of EPA financial assistance. OECRC accomplishes in accordance with the procedure described in the Case Resolution Manual.
