



## **OVERVIEW**

## **EPA received \$3 billion in the Inflation Reduction Act (IRA)**

\$2.8 billion for grants, \$200 million for technical assistance.

EPA received \$100 million in the FY-22 and \$108 million in the FY-23 budgets to support EJ activities in OEJECR.

Over half of those funds are planned to be allocated to grants and technical assistance.



# IRA – E&CJ COMMUNITY GRANT PROGRAM STATUTORY LANGUAGE / DEFINITIONS

- "(3) ELIGIBLE ENTITIES.—In this subsection, the term 'eligible entity' means—
- "(A) a partnership between—
  - "(i) an Indian tribe, a local government, or an institution of higher education; and
  - "(ii) a community-based nonprofit organization;
- "(B) a community-based nonprofit organization; or
- "(C) a partnership of community-based nonprofit organizations.



# IRA – E&CJ COMMUNITY GRANT PROGRAM STATUTORY LANGUAGE / DEFINITIONS

- (a) APPROPRIATION.—In addition to amounts otherwise available, there is appropriated to the Administrator for fiscal year 2022, out of any money in the Treasury not otherwise appropriated—
- "(1) \$2,800,000,000 to remain available until September 30, 2026, to award grants for the activities described in subsection (b); and "(2) \$200,000,000 to remain available until September 30, 2026, to provide technical assistance to eligible entities related to grants awarded under this section.
- "(b) GRANTS.— "(1) IN GENERAL.—The Administrator shall use amounts made available under subsection (a)(1) to award grants for periods of up to 3 years to eligible entities to carry out activities described in paragraph (2) that benefit disadvantaged communities, as defined by the Administrator.

- Prove that investing in communities are the best investments to solve the toughest problems in places with the biggest challenges.
- Achieve lasting, meaningful <u>change</u> on the ground.
- Provide substantial oversight and tracking of all E&CJ awards to prevent waste, fraud, and abuse and achieve program objectives.



## FIRST STEP - FUNDAMENTAL SUPPORT

#### **EJ Thriving Communities Technical Assistance Centers (TCTACs)**

#### • Background/Purpose:

- TCTACs will provide <u>fundamental</u> technical assistance (TA) services, including grant writing training, grant mgmt training, and capacity-building support to underserved communities throughout the nation. Centers are funded by both EPA and Dept. of Energy (DOE).
- Access: Ground floor, front door entry point for communities. No barrier to entry.

## Grant Funding and number of Awards

- No IRA Funds, 100% of funding provided by baseline EJ appropriations (plus DOE funds)
- \$177 million total; \$10 \$13 million million per Award (5-year Project Period)
- 13 Regional TCTACs delivering direct TA to communities in their Regions
- 3 National TCTACs lift up and support the Regional TCTACs; fill gaps in coverage
- Region 8 and Region 1 plan to open competitions for their TCTACs in July 2023

#### Award Status


- 6 TCTACs awarded as of June 28<sup>th</sup>
- Other TCTACs are on track for award by mid July

## STEP TWO - ACCESSIBLE GRANT FUNDING

#### EJ Thriving Communities Grantmaking Program (EJ TCGM)

#### • <u>Background/Purpose</u>:

• EPA will fund 11 pass-through entities (i.e., Grantmakers) nationwide to provide (sub)grants to community-based nonprofits and other eligible subrecipients for assessment, planning, and project development activities.

#### Grant Funding

- \$550 million total; \$50 million per Award
- 100% IRA funds (approximately)
- 80% of total awarded funds must go to communities via subgrants (Eligibility Criteria)
- Grantee Type(s): Colleges/Universities; Large Nonprofits; Tribal Govt./Organizations
- Eligible Subrecipients: CBOs, Tribal entities, US Territories, local governments, colleges/universities

#### Access:

• Low barrier to entry. Ability to provide thousands of subgrants nationwide in next 3 years w/simplified process.

### • Timing

• RFA closes June 30th. Selections in November 2023. Awards in February 2024.

Competition closes on June 30<sup>th</sup>

## STEP3-LEGACY EJ GRANT PROGRAMS

## Applications currently under review!

#### **EJ Collaborative Problem-Solving Grants (EJCPS)**

- <u>Description</u>: Cooperative agreement grants to CBOs. Expansion of EPA's legacy EJ community grant program with larger awards to pilot implementation activities through community-centered collaborative partnerships
- Grant Funding: \$30 million of IRA funds. Up to \$500K per project.
- <u>Target Number of Projects Awarded</u>: 83
- Timing: Selections announced in September 2023 and awards in November/December

### **EJ Government to Government Grants (EJG2G)**

- <u>Description</u>: Grants to government agencies partnered with CBOs. Expansion of EPA's legacy EJ government grants program with larger awards to gov. agencies partnering with communities to develop plans, projects, and pilot implementation activities
- Grant Funding: \$40 million of IRA funds and \$30 million of baseline. Up to \$1 million per project.
- <u>Target Number of Projects:</u> 70
- <u>Timing</u>: Selections announced in September 2023 and awards in December

Winter/spring 2023 received public feedback on design of the implementation grants. RFA to be released in September 2023.

## **Environmental and Climate Justice (E&CJ) Community Change Grants**

## Background/Purpose:

 Change grants will provide levels of funding to communities to change the reality on the ground (i.e., infrastructure, revitalization work, and significant implementation activities) related to EJ issues

## • **Grant Funding:**

- Up to \$2 Billion of IRA funds
- Directly funded through EPA

## • **Timing:**

 Grant competition window opens in September 2023. One-year open window for receiving proposals. Proposals scored on a monthly basis.

## Innovative Application Process:

Written applications, oral presentations, and rolling application period

## **Environmental and Climate Justice (E&CJ) Community Change Grants**

- Funding per Award (cooperative agreements):
  - \$10 million \$20 million per award
  - Awards made in the Regions and HQ
  - 3-year Project Period
- Award Timing and # of Awards:
  - Change grants will begin being awarded in Q2 FY24
  - Change grants awarded on a rolling basis for at least one year
  - # of awards will be significant over the one-year period
  - # of awards depends on volume of applications received
- Compliance with Build America Buy America (BABA) and Davis-Bacon

# IRA – E&CJ COMMUNITY GRANT PROGRAM STATUTORY LANGUAGE / DEFINITIONS

Subtitle B—Hazardous Materials

SEC. 60201. ENVIRONMENTAL AND CLIMATE JUSTICE BLOCK GRANTS.

The Clean Air Act is amended by inserting after section 137, as added by subtitle A of this title, the following: "SEC. 138. ENVIRONMENTAL AND CLIMATE JUSTICE BLOCK GRANTS."

- (a) APPROPRIATION.—In addition to amounts otherwise available, there is appropriated to the Administrator for fiscal year 2022, out of any money in the Treasury not otherwise appropriated—
- "(1) \$2,800,000,000 to remain available until September 30, 2026, to award grants for the activities described in subsection (b); and "(2) \$200,000,000 to remain available until September 30, 2026, to provide technical assistance to eligible entities related to grants awarded under this section.
- "(b) GRANTS.— "(1) IN GENERAL.—The Administrator shall use amounts made available under subsection (a)(1) to award grants for periods of up to 3 years to eligible entities to carry out activities described in paragraph (2) that benefit disadvantaged communities, as defined by the Administrator.
- "(2) ELIGIBLE ACTIVITIES.—An eligible entity may use a grant awarded under this subsection for—
- "(A) community-led air and other pollution monitoring, prevention, and remediation, and investments in low- and zero emission and resilient technologies and related infrastructure and workforce development that help reduce greenhouse gas (as defined in section 211(o)(1)(G) (as in effect on the date of enactment of this section)) emissions and other air pollutants;
- "(B) mitigating climate and health risks from urban heat islands, extreme heat, wood heater emissions, and wildfire events;
- "(C) climate resiliency and adaptation;
- "(D) reducing indoor toxics and indoor air pollution; or
- "(E) facilitating engagement of disadvantaged communities in State and Federal public processes, including facilitating such engagement in advisory groups, workshops, and rulemakings.
- "(3) ELIGIBLE ENTITIES.—In this subsection, the term 'eligible entity' means—
- "(A) a partnership between—
  - "(i) an Indian tribe, a local government, or an institution of higher education; and
  - "(ii) a community-based nonprofit organization;
- "(B) a community-based nonprofit organization; or
- "(C) a partnership of community-based nonprofit organizations.
- "(c) ADMINISTRATIVE COSTS.—The Administrator shall reserve 7 percent of the amounts made available under subsection (a) for administrative costs to carry out this section."
