PM<sub>2.5</sub> - particles that are 2.5 micrometers and smaller

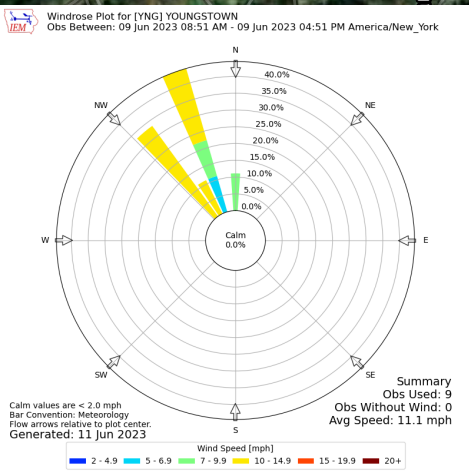
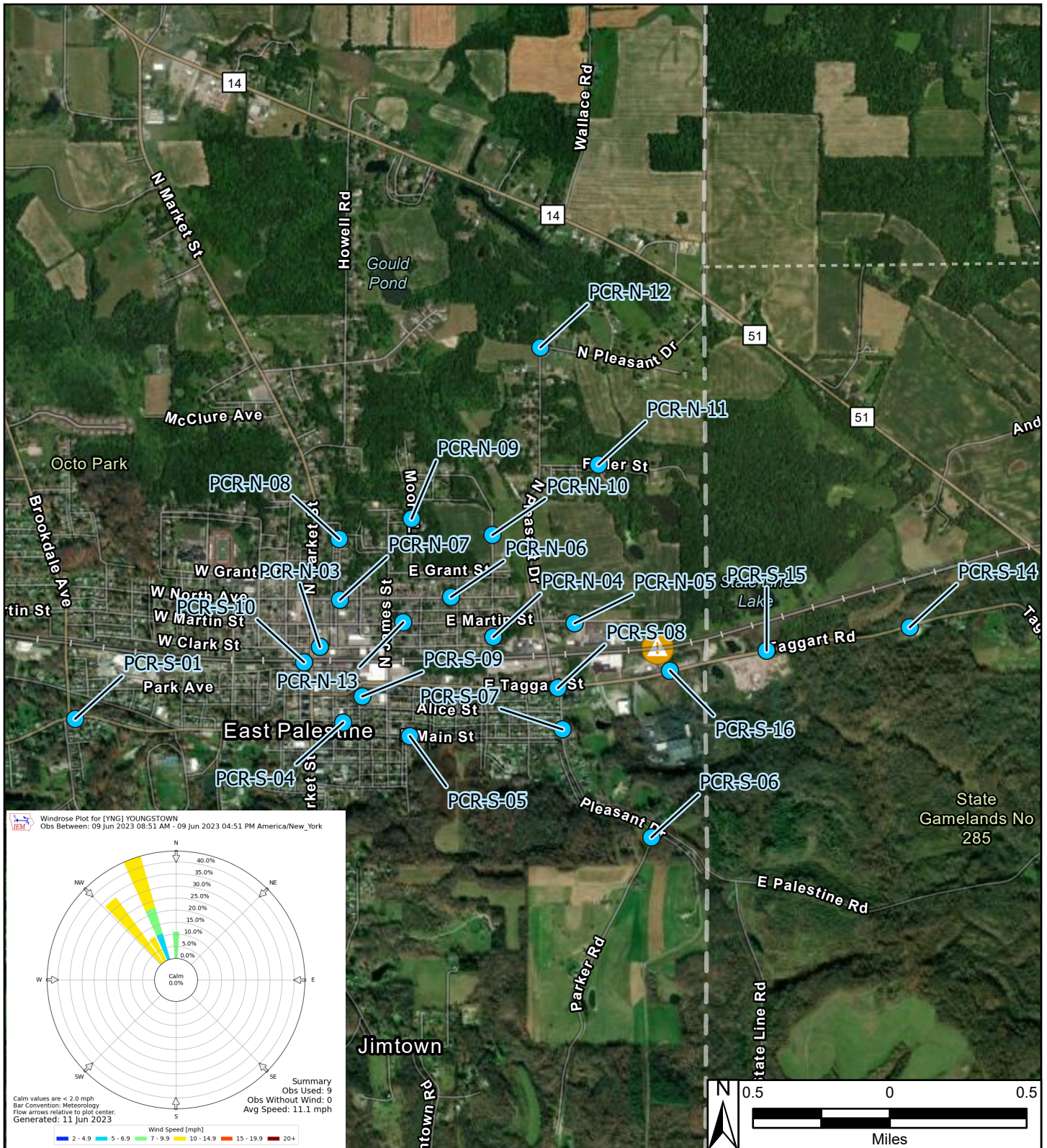
