Pursuant to Section 307(b)(1) of the Clean Air Act, 42 U.S.C. § 7607(b)(1); Federal Rule of Appellate Procedure 15(a); and D.C. Circuit Rule 15, the Interstate Natural Gas Association of America ("INGAA") and American Petroleum Institute ("API") hereby petition this Court for review of a final rule of the United States Environmental Protection Agency.
