- iii. Harmful Algal Blooms, including in lakes. What is the Agency doing to address this problem?
- iv. Recycling, food waste, and waste management facilities.
  - i. Metal recycling in Carolina, Puerto Rico. A company is receiving old trucks and the grounds are becoming contaminated due to chemicals released. Would like clarity and to discuss how the federal government regulates contamination from companies like this. How can communities work with the EPA to **reinforce** the environmental regulations of different communities and be a resource to local officials?
- v. Clean Air Act regulations and Air Particulates-would like to follow up on what is being done to regulate.
- vi. Polluted former industrial sites and cleaned up former industrial sites that may have a negative stigma against them. What is being done on the federal level to track these? What resources are available to local officials?
