Re: Notice of Termination to SDWA Section 1431 Unilateral Administrative Order

Dear Rebecca Losli:

The United States Environmental Protection Agency (“EPA”) has determined Illinois American Water Co. has met the terms of the Safe Drinking Water Act Section 1431 Unilateral Administrative Order (UAO), dated August 2, 2021. EPA issued the UAO to Illinois American Water Co. and the City of Cahokia Heights. Pursuant to paragraph 82, the UAO is terminated with respect to each Respondent once said Respondent receives written notice from EPA that the Respondent has “demonstrated, to the satisfaction of EPA, that the terms of this Order, including any additional tasks determined by EPA to be required under this Order or any continuing obligation or promises, have been satisfactorily completed.” EPA has determined that Illinois American Water Company has complied with terms of the order and is released from the obligations thereunder.

Termination of the order does not relieve Illinois American Water Company of its ongoing obligation to comply with the requirements of the Safe Drinking Water Act and its regulations. In its role as the primacy agency, Illinois Environmental Protection Agency will continue to work with Illinois American Water Company to maintain compliance with applicable requirements. EPA will continue to track compliance of public water systems in Illinois, including Illinois American Water Company, through routine coordination with the state.

The UAO was issued pursuant to the authority vested in the Administrator of the EPA by Section 1431(a) of the Safe Drinking Water Act, 42 U.S.C. § 300i(a). The authority to issue or terminate this UAO was delegated to the Regional Administrators by Delegation No. 9-17.
