#### **PETITION FOR REVIEW**

Under 42 U.S.C. § 7607(b)(1) and Federal Rule of Appellate Procedure 15(a), Petitioner Energy Transfer LP petitions this Court for review of Respondents United States Environmental Protection Agency and Administrator Michael S. Regan's promulgation of a federal implementation plan for Mississippi regarding the interstate transport requirements of 42 U.S.C. § 7410(a)(2)(d)(i)(I) for the 2015 8hour ozone national ambient air quality standard, titled "Federal 'Good Neighbor Plan' for the 2015 Ozone National Ambient Air Quality Standards," 88 Fed. Reg. 36,654 (June 5, 2023) ("Final Rule").<sup>1</sup> See FED. R. APP. P. 15(a)(2)(C) ("The petition must . . . specify the order or part thereof to be reviewed."). EPA has no authority to promulgate a FIP for Mississippi unless and until it has lawfully disapproved Mississippi's state implementation plan. 42 U.S.C. § 7410(c)(1). This Court recently granted Mississippi Petitioners a stay of EPA's disapproval of Mississippi's state implementation plan. Order, *Texas v. EPA*, No. 23-60069 (5th Cir. June 8, 2023).

Jurisdiction and venue lie in this Court under 42 U.S.C. § 7607(b)(1). The challenged action's promulgation of a FIP for Mississippi is a "locally or regionally applicable" action and is not "based on a determination of nationwide scope or effect." *See id.*; Order, *Texas v. EPA*, No. 23-60069 (5th Cir. May 1, 2023); *Texas v. EPA*, 829 F.3d 405, 418–24 (5th Cir. 2016). This petition for review is timely filed within sixty days of the challenged action's publication in the Federal Register. *See* 42 U.S.C. § 7607(b)(1). Petitioner requests that the Court vacate, set aside, and hold unlawful the EPA's promulgation of the FIP for Mississippi.<sup>2</sup>
