## Re: Informal Resolution/Tolling of Preliminary Findings Timeframe

Dear Executive Director Sobeck:

This letter concerns U.S. Environmental Protection Agency ("EPA") Complaint No. 01RNO-23-R9 involving the California State Water Resources Control Board ("Board"). On August 8, 2023, the Office of External Civil Rights Compliance ("OECRC") accepted the complaint for investigation. OECRC is required by regulation to attempt to resolve complaints informally whenever possible. OECRC representatives described the process of developing and executing a facilitated Informal Resolution Agreement ("IRA") to Executive Director Eileen Sobeck and the Board's Counsel Michael A.M. Lauffer on August 28, 2023. On September 7, 2023, Mr. Lauffer informed OECRC that the Board agrees to engage in negotiations toward the execution of an IRA. Consequently, OECRC will suspend its 180-day timeframe for issuing Preliminary Findings (40 C.F.R. § 7.115(c)(1)) for the duration of the IRA process. OECRC will ensure that this process occurs without undue delay.

The goal of the IRA negotiation process is to reach an agreement between the Board and OECRC that resolves the issues accepted for investigation. If the Board and OECRC fail to reach an informal resolution agreement, OECRC will notify the Board and the Complainant of that fact and resume the process for issuing preliminary findings.<sup>2</sup> To facilitate the informal resolution agreement process, we will continue to engage the Board, as well as the Complainant, to gather the necessary facts and information so that we may provide you with a draft IRA as soon as possible for your consideration. Engagement during the IRA negotiation process may also include EPA facilitated meetings between the Board and the Complainants, with the consent of the Recipient and Complainants.

In the event OECRC and the Boards cannot reach an Informal Resolution Agreement, OECRC will resume the process for issuing preliminary findings within 180 days of the start of the investigation – excluding the period spent in the informal resolution agreement process.
