I. CONSENT AGREEMENT

A. Preliminary Statement

1. This is a civil administrative penalty assessment proceeding brought under section 205(c)(1) of the Clean Air Act (“CAA” or the “Act”), 42 U.S.C. § 7524(c)(1), and sections 22.13 and 22.18 of the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits (“Consolidated Rules”), as codified at 40 C.F.R. Part 22. In accordance with 40 C.F.R. §§ 22.13 and 22.18, entry

of this Consent Agreement and Final Order ("CAFO") simultaneously commences and concludes this matter.

2. Complainant is the Director of the Enforcement and Compliance Assurance Division, U.S. Environmental Protection Agency Region IX (the "EPA"), who has been duly delegated the authority to commence and settle civil administrative penalty proceedings under section 205(c)(1) of the CAA, 42 U.S.C. § 7424 (c)(1).

3. Respondent is Diamond Eye Manufacturing, Inc., ("Diamond Eye"), an Oregon corporation headquartered at 107 W Main Street, Athena, Oregon 97813. Diamond Eye manufactures, among other items, motor vehicle exhaust parts.

4. Complainant and Respondent, having agreed that settlement of this action is in the public interest, consent to the entry of this CAFO without adjudication of any issues of law or fact herein, and Respondent agrees to comply with the terms of this CAFO.

B. Governing Law

5. This proceeding arises under Part A of Title II of the CAA, CAA §§ 202-219, 42 U.S.C. §§ 7521-7554, and the regulations promulgated thereunder. These laws aim to reduce emissions from mobile sources of air pollution, including particulate matter ("PM"), non-methane hydrocarbons ("NMHC"), oxides of nitrogen ("NOx"), and carbon monoxide ("CO"). In creating the CAA, Congress found, in part, that "the increasing use of motor vehicles . . . has resulted in mounting dangers to the public health and welfare." CAA § 101(a)(2), 42 U.S.C. § 7401(a)(2).

6. EPA's allegations in this CAFO concern parts or components for motor vehicles and engines subject to emission standards. The CAA requires EPA to prescribe and revise, by regulation, standards applicable to the emission of any air pollutant from new motor vehicles or

engines that cause or contribute to air pollution which may reasonably be anticipated to endanger public health or welfare. *See* CAA § 202(a)(1) and (3)(B), 42 U.S.C. § 7521(a)(1) and (3)(B). As required by the CAA, the emission standards must “reflect the greatest degree of emission reduction achievable through the application of [available] technology.” CAA § 202(a)(3)(A)(i), 42 U.S.C. § 7521(a)(3)(A)(i).

7. Under Section 202 of the CAA, 42 U.S.C. § 7521, EPA has promulgated emission standards for PM, NMHC, NO_x and CO that are applicable to motor vehicles and motor vehicle engines based on a vehicle’s or engine’s class and model year. *See generally* 40 C.F.R. Part 86.

8. Section 203(a)(1) of the CAA prohibits a vehicle manufacturer from selling a new motor vehicle in the United States unless the vehicle is covered by a certificate of conformity. 42 U.S.C. § 7522(a)(1).

9. The EPA issues certificates of conformity to vehicle manufacturers under section 206(a) of the CAA, 42 U.S.C. § 7525(a), to certify that a particular group of motor vehicles conforms to applicable EPA requirements governing motor vehicle emissions.

10. The application for a certificate of conformity must describe, among other things, the emissions-related elements of design of the motor vehicle or motor vehicle engine. *See* 40 C.F.R. § 86.1844-01.

11. “Element of design” is defined in 40 C.F.R. § 86.1803-01 as “any control system (i.e., computer software, electronic control system, emission control system, computer logic), and/or control system calibrations, and/or the results of systems interaction, and/or hardware items on a motor vehicle or motor vehicle engine.”

12. EPA-certified motor vehicles and motor vehicle engines include a variety of hardware,

software devices (tuners) and software (tunes) or elements of design that control emissions of air pollutants. Manufacturers employ certain hardware devices as emission control systems to manage and treat exhaust to reduce levels of regulated pollutants from being created or emitted into the ambient air and meet the emission standards in 40 C.F.R. Part 86. Such devices include diesel particulate filters (“DPF”), exhaust gas recirculation (“EGR”), diesel oxidation catalysts (“DOC”), nitrogen oxide adsorbing catalysts (“NAC”), three-way catalysts (“TWC”), and selective catalytic reduction (“SCR”).

13. Pursuant to Section 203(a)(3)(B) of CAA, 42 U.S.C. § 7522(a)(3)(B),

The following acts and the causing thereof are prohibited—for any person to manufacture or sell, or offer to sell, or install, any part or component intended for use with, or as part of, any motor vehicle or motor vehicle engine, where a principal effect of the part or component is to bypass, defeat, or render inoperative any device or element of design installed on or in a motor vehicle or motor vehicle engine in compliance with regulations under this subchapter, and where the person knows or should know that such part or component is being offered for sale or installed for such use or put to such use[.]

14. “Person” is defined in Section 302(e) of the CAA, 42 U.S.C. § 7602(e), to include “an individual, corporation, partnership, association, State, municipality, political subdivision of a State, and any agency, department, or instrumentality of the United States and any officer, agent or employee thereof.”

15. “Motor vehicle” is defined in Section 216(2) of the CAA, 42 U.S.C. § 7550(2), as “any self-propelled vehicle designed for transporting persons or property on a street or highway.”

16. Any person who violates Section 203(a)(3)(B) of CAA, 42 U.S.C. § 7522(a)(3)(B), is subject to a civil penalty of up to \$5,580 for each violation. CAA § 205(a), 42 U.S.C. § 7524(a), 40 C.F.R. § 19.4, Table 1.

C. Allegations

17. Complainant re-alleges and incorporates by reference herein Paragraphs 1 through

16 of this CAFO.

18. At all times relevant to this CAFO, Respondent was a "person" as defined by Section 302(e) of the CAA, 42 U.S.C. § 7602(e).

19. Respondent sells and distributes motor vehicle parts to various individual customers located throughout the United States.

20. On June 19, 2019, EPA issued an information request pursuant to Section 208(a) of the CAA, 42 U.S.C. § 7542(a), to Respondent regarding hardware that Respondent sold and/or offered for sale from January 1, 2017.

21. In Respondent's responses, dated August 22, 2019, October 11, 2019, and July 3, 2020, to EPA's information request, Respondent indicated that it sold and/or offered for sale at least thirty-three thousand, one thirty-four (33,134) parts or components ("Subject Parts," each of which is a "Subject Part") between January 1, 2017, and June 19, 2019, as identified in the Appendix to this CAFO.

22. The Subject Parts consist of thirty-three thousand, one thirty-four (33,134) exhaust emission control delete hardware (sometimes referred to as "straight" or "delete" pipes).

23. Hardware devices and emission control systems such as DOC, NAC, DPF and/or SCR systems are "device[s] or element[s] of design installed on or in a motor vehicle or motor vehicle engine in compliance with [CAA] regulations" within the meaning of Section 203(a)(3)(B) of the CAA, 42U.S.C. § 7522(a)(3)(B).

24. Each Subject Part is, and at all relevant times herein was, intended for use with certified motor vehicles and motor vehicle engines including General Motors Company, Ford Motor Company, and Fiat Chrysler Automobiles US LLC diesel trucks ("Motor Vehicles").

25. A principal effect of each Subject Part is to bypass, defeat, or render inoperative

device(s) and/or element(s) of design such as the DOC, NAC, DPF and/or SCR systems that were installed on these Motor Vehicles.

26. Respondent knew or should have known that each Subject Part was being offered for sale or installed for such use or put to such use.

27. Respondent's sales and/or offers for sale of thirty-three thousand, one thirty-four (33,134) Subject Parts between January 1, 2017, and June 19, 2019, constitute thirty-three thousand, one thirty-four (33,134) violations of Section 203(a)(3)(B) of CAA, 42 U.S.C. § 7522(a)(3)(B).

D. Terms of Consent Agreement

28. In accordance with 40 C.F.R. § 22.18(b)(2) and for the purpose of this proceeding, Respondent: a) admits that EPA has jurisdiction over the subject matter alleged in this CAFO and over Respondent; b) neither admits nor denies the specific factual allegations contained in Section I.C of this CAFO; c) consents to the assessment of a civil penalty as stated below; d) consents to the conditions specified in this CAFO; e) waives any right to contest the allegations set forth in Section I.C of this CAFO; and f) waives its rights to appeal the proposed Order contained in this CAFO.

Civil Penalty

29. Respondent agrees to the assessment of a civil penalty in the amount of two hundred sixty-five thousand dollars (\$265,000) ("Assessed Penalty") as final settlement of the civil claims against Respondent arising under the CAA as alleged in Section I.C of this CAFO. The EPA has reduced the civil penalty on the basis of information produced by Respondent demonstrating its inability to pay a higher civil penalty.

30. Respondent agrees to pay the Assessed Penalty within thirty (30) days of the

Effective Date of this CAFO.

31. Respondent agrees to pay the Assessed Penalty using any method, or combination of methods, provided on the website <https://www.epa.gov/financial/makepayment>, and identifying the payment with “Docket No. CAA-09-2023-0022.” Within 24 hours of payment of the Assessed Penalty, Respondent agrees to send proof of payment to Nathan Dancher at dancher.nathan@epa.gov and the EPA Region 9 Regional Hearing Clerk at R9HearingClerk@epa.gov. “Proof of payment” means a copy of the check, confirmation of credit card or debit card payment, confirmation of wire or automated clearinghouse transfer, and any other information required to demonstrate the payment of the Assessed Payment has been made in accordance with this CAFO. The proof of payment shall be identified with “Docket No. CAA-09-2023-0022.”

32. Payments of the above civil administrative penalty shall not be used by Respondent or any other person as a tax deduction from Respondent’s federal, state, or local taxes.

33. If Respondent does not pay the Assessed Penalty within 30 days of the effective date of this CAFO, then Respondent shall pay to EPA a stipulated penalty in the amount of one thousand dollars (\$1,000) for each day the default continues plus the remaining balance of the Assessed Penalty upon written demand by EPA.

34. If Respondent fails to timely pay any portion of the penalty due under this CAFO, EPA may:

- a. request the Attorney General to bring a civil action in an appropriate district court to recover: the amount assessed; interest at rates established pursuant to 26 U.S.C. § 6621(a)(2); the United States’ enforcement expenses; and a 10 percent quarterly nonpayment penalty, 42 U.S.C. § 7524(c)(6);

- b. refer the debt to a credit reporting agency or a collection agency, 42 U.S.C. § 7524(c)(6), 40 C.F.R. §§ 13.13, 13.14, and 13.33;
- c. collect the debt by administrative offset (i.e., the withholding of money payable by the United States to, or held by the United States for, a person to satisfy the debt the person owes the Government), which includes, but is not limited to, referral to the Internal Revenue Service for offset against income tax refunds, 40 C.F.R. Part 13, Subparts C and H; and
- d. suspend or revoke Respondent's licenses or other privileges granted by EPA, or suspend or disqualify Respondent from doing business with EPA or engaging in programs EPA sponsors or funds, 40 C.F.R. § 13.17.

Respondent's Certification of Compliance

35. Respondent certifies that as of the date of its signing this Consent Agreement, Respondent is complying fully with section 203(a)(3) of the CAA, 42 U.S.C. §7522(a)(3).
36. Respondent is aware of EPA's November 23, 2020 "Tampering Policy: The EPA Enforcement Policy on Vehicle and Engine Tampering and Aftermarket Defeat Devices under the Clean Air Act."
37. Respondent represents that it has completed, or will have completed, with the exception of the time of continued posting of the item in paragraph 37.h., all of the following items as of the effective date of the CAFO in this matter. The initial posting referenced in paragraph 37.h. shall have been done as of the time of the effective date of the CAFO in this matter, and shall continue to be posted for eight consecutive weeks following the initial posting consistent with paragraph 37.h.:
- a. permanently destroyed all of the Subject Parts in its possession or control and submitted reports to EPA documenting such destruction;
 - b. ceased offering or making available any technical support or other information

(including marketing materials) pertaining to the installation, manufacture, sale, use, or repair of any Subject Part, and confirmed that any such technical support such as installation instructions for Subject Parts on Respondent's website have been or are taken down;

- c. notified all authorized dealers and customers that Respondent is no longer honoring warranty claims pertaining to any Subject Part and that Respondent is no longer supplying technical support pertaining to the installation, manufacture, sale, use or repair of any Subject Part; and instructed all authorized dealers and customers to refuse to honor any warranty claims pertaining to any Subject Part and to refuse to supply any technical support or other information (including marketing materials) pertaining to the installation, manufacture, sale, use, or repair of any Subject Part;
- d. revised all marketing materials to ensure that such materials do not include any information, including but not limited to installation instructions or demonstrations, that pertains or relates in any way to replacing, overwriting, deleting, bypassing, defeating, or rendering inoperative any emission control device or emissions-related element of design;
- e. notified all authorized dealers, and all customers to which Respondent sold a Subject Part since January 1, 2017, that it entered into a settlement with EPA;
- f. notified Respondent's employees of the settlement;
- g. confirmed that it is not in possession of any ownership or interest in any person or entity that Respondent knows, or with reasonable diligence should know, manufactures, sells, offers to sell, distributes or installs in a motor vehicle or motor vehicle engine any Subject Part; not assisting any person or entity with the

manufacture, sell, offer to sell, distribution, or installation of any Subject Part in a motor vehicle or motor vehicle engine; and not earning any income from the distribution or installation of any Subject Part in a motor vehicle or motor vehicle engine; and

- h. placed an announcement on Respondent's website and any social media platforms that Respondent uses indicating that it has entered into a settlement with EPA. Such announcement(s) shall remain posted or up on its website and social media for a period of at least eight weeks.

38. Resolution of liability effected by this CAFO is conditioned upon completion of the items set forth in Paragraph 37.

39. The provisions of this CAFO shall apply to and be binding upon Respondent and its officers, directors, employees, agents, trustees, servants, authorized representatives, successors, and assigns. Respondent must give written notice and a copy of this CAFO to any successors in interest prior to any transfer of ownership or control of any portion of or interest in Respondent. This notice requirement shall terminate when Respondent has discharged all of its obligations under this CAFO, including without limitation those in Paragraphs 30-33 and 37.

40. Simultaneously with such notice, Respondent shall provide written notice of such transfer, assignment, or delegation to EPA. In the event of any such transfer, assignment, or delegation, Respondent shall not be released from the obligations or liabilities of this CAFO unless EPA has provided written approval of the release of said obligations or liabilities.

41. By signing this CAFO, Respondent acknowledges that this CAFO will be available to the public and agrees that this CAFO does not contain any confidential business information or personally identifiable information.

42. By signing this CAFO, the undersigned representative of Complainant and the undersigned

representative of Respondent each certify that he or she is fully authorized to execute and enter into the terms and conditions of this CAFO and has the legal capacity to bind the party he or she represents to this CAFO. This CAFO may be signed in counterparts, and its validity shall not be challenged on that basis.

43. By signing this CAFO, Respondent certifies that the information it has supplied concerning this matter was at the time of submission true, accurate, and complete for each such submission, response, and statement. Respondent acknowledges that there are significant penalties for submitting false or misleading information, including the possibility of fines and imprisonment for knowing submission of such information, under 18 U.S.C. § 1001.

44. Each party agrees to bear its own costs and attorney's fees in this action.

E. Effect of Consent Agreement and Final Order

45. In accordance with 40 C.F.R. § 22.18(c), completion of the terms of this CAFO resolves only Respondent's liability for federal civil penalties for the violations and facts specifically alleged above.

46. Nothing in this CAFO shall relieve Respondent of the duty to comply with all applicable provisions of the Act and other federal, state, or local laws or statutes, nor shall it restrict EPA's authority to seek compliance with any applicable laws or regulations, nor shall it be construed to be a ruling on, or determination of, any issue related to any federal, state, or local permit.

47. This CAFO constitutes the entire agreement between the parties and supersedes any prior agreements or understandings, whether written or oral, among the parties with respect to the subject matter hereof.

F. Effective Date

48. Respondent and Complainant agree to issuance of the attached Final Order. Upon filing, EPA will transmit a copy of the filed CAFO to the Respondent. This CAFO shall become effective after execution of the Final Order by the Regional Judicial Officer on the date of filing with the Regional Hearing Clerk.
