**SUBJECT: PRIA M007 Request to Extend Exclusive Use of Data for Products
Containing Bicyclopyrone Technical (EPA Reg. No. 100-1467)**

Dear Ms. McFarley:

Syngenta Crop Protection, LLC is herein requesting a three year exclusive use extension for products that contain bicyclopyrone (trade name Optogen™), registered originally for use in corn, April 24, 2015. On January 14, 2022, the Agency approved the use of bicyclopyrone on 3 minor crops: rosemary, wormwood, lemongrass and on March 17, 2022, the Agency approved the use on an additional 13 minor crops. Each of these crops was registered within 7 years of the date the original registration, qualify as minor use crops (production <300,000 acres in the U.S.), and meet at least one of more of the criteria outlined in FIFRA Section 3(c)(1)(F)(ii). In addition, these minor crops are commercially available and are marketed under the Syngenta brand, Optogen™ (EPA Registration No. 100-1465). Enclosed is Syngenta's petition for EPA to extend the period of exclusive use for an additional 3 years, extending the exclusivity period to April 15, 2028.
