What is the purpose of this document?

This document identifies the types of information that owners and operators of existing affected units in the Iron and Steel Mills and Ferroalloy Manufacturing Industry must submit in order to satisfy the initial notification requirements of the Federal "Good Neighbor Plan" for the 2015 Ozone National Ambient Air Quality Standards (40 CFR 52.43(h)). You may complete and submit this form to satisfy the requirements of 40 CFR 52.43(h) or submit the required information in another format if desired.¹

Am I required to submit an Initial Notification?

You must submit an Initial Notification if you are the owner or operator of an existing affected unit in the Iron and Steel Mills and Ferroalloy Manufacturing Industry subject to the requirements of the Federal "Good Neighbor Plan" for the 2015 Ozone National Ambient Air Quality Standards in 40 CFR 52.43. An existing affected unit under this provision is an existing reheat furnace at an iron and steel mill or ferroalloy manufacturing facility that directly emits or has the potential to emit (PTE) 100 tons per year or more of NO_X as of August 4, 2023, does not have low-NO_X burners installed, and is located within any of the States listed in 40 CFR 52.40(c)(2), including Indian country located within the borders of any such State(s) (40 CFR 52.43(b), (h)). New affected units constructed after this date are not required to submit an initial notification.

When must I submit an Initial Notification?

For all existing affected units, the Initial Notification must be submitted no later than December 4, 2023 (40 CFR 52.43(h)(2)).

To whom do I submit the Initial Notification?

Initial Notifications shall be submitted electronically using the Compliance and Emissions Data Reporting Interface (CEDRI) through EPA's <u>Central Data Exchange</u> or analogous electronic submission system provided by the EPA. The initial notification shall be submitted no later than December 4, 2023, and in PDF format.

CEDRI is a web-based application for the electronic reporting of various reports required in 40 CFR Parts 52, 60, 62 and 63. Instructions for registering with and submitting notifications to CEDRI can be found in the <u>CEDRI CDX User Guide</u>.

To submit an Initial Notification through CEDRI, select 'Create a Report' to start a new report. In the 'Select Report Type' window, select the Report Type 'Notification Report'. By adding Part 52 and Subpart 42 to the search criteria, CEDRI will display the selected reports. 'Add' the selected report to the 'Selected Reports Table' and proceed to the next step to upload the PDF file. Additional details for creating reports in CEDRI can be found in CEDRI's Navigating the Create a Report Workflow Job Aide.
