The Massachusetts Department of Environmental Protection is the agency responsible for administering the provisions of the Safe Drinking Water Act, Section 42 U.S.C. § 300g-9 (c)(3). The Act requires the State agency (MassDEP) with primacy to prepare a triennial report, stating the progress the agency has made in adopting its Capacity Development Strategy, which is designed to improve the technical, financial and managerial capacity of public water systems in the State.

The attached report fulfills the requirements of the Act by demonstrating that MassDEP has successfully implemented its Capacity Development Strategy and that this initiative has had a direct and positive impact on the quality of drinking water in Massachusetts. A few short examples of the work that MassDEP has completed include:

- Registering and evaluating forty-three (32) new public watersystems.
- Evaluating one thousand one hundred and forty (1,140) public water systems via the sanitary surveys process.
- Evaluating, categorizing and providing technical assistance and outreach to address the four thousand four hundred and ninety-eight (4,498) technical, financial and managerial issues (Scheduled Actions) identified at public water systems during the sanitary surveys process.

#### **EXECUTIVE SUMMARY**

The Massachusetts Department of Environmental Protection (MassDEP) is the responsible agency for administering the provisions of the Public Health Service Act (Title XIV), also called the Safe Drinking Water Act (SDWA or the Act), Section 42 U.S.C.A. § 300g-9 (c)(3). The Act requires (Section 1420(c)(3)), the head of the State agency (MassDEP) with primacy, to submit to the Governor a triennial report, stating the progress the agency has made in adopting its capacity development strategy. The capacity strategy is designed to improve the technical, managerial and financial capacity of public water systems in the State. The report, which requires no action by the Governor, is attached, and will be made available to the public via MassDEP's web site and/or upon request.

The MassDEP through its Drinking Water Program (DWP) administers and enforces the requirements of the federal SDWA. From its headquarters in Boston and regional offices in Lakeville, Springfield, Wilmington, and Worcester, MassDEP is involved in every facet of ensuring that public water systems in Massachusetts provide and deliver drinking water that is safe and fit to everyone who lives in, works in, and visits our State. To further enhance its efforts to promote the public health and general welfare of the users of water, as well as to comply with the new federal Capacity Development requirements established by section 1420(c)(2) of the Act, the MassDEP developed and submitted to EPA in August 2000 a capacity development strategy. MassDEP submitted an updated Capacity Development Strategy in February 2022, which EPA approved. The capacity development strategy was designed to improve the technical, managerial, and financial (TMF) capabilities of public water systems so that they can achieve compliance with the requirements of the Act.

This report fulfills the requirements of section 1420(c)(3) of the Act by demonstrating that MassDEP has successfully implemented its Capacity Development Strategy and that this initiative has had a direct and positive impact on the quality of drinking water in Massachusetts.

#### **BACKGROUND INFORMATION**

A public water system's capacity is determined by its ability to plan for, achieve, and maintain compliance with applicable federal and state drinking water standards now and in the foreseeable future. Based upon the research and technical assistance efforts of waterworks professionals and EPA guidance, capacity is known to have three components: technical, managerial, and financial. Adequate capability in all three areas is necessary for the successful operation of a public water system.

Capacity development is the process through which public water systems acquire and maintain adequate technical, managerial, and financial capabilities to assist them in complying with the Massachusetts regulations that implement the Act, published at 310 CMR 22.00. The 1996 Amendments to the SDWA added capacity development provisions that provide a framework for States and public water systems to work together to help ensure that systems acquire and maintain these capabilities in order to meet current and future federal and state public health protection objectives. MassDEP's Capacity Development Strategy is the framework that MassDEP uses to improve the technical, managerial, and financial capacity of public water systems in Massachusetts.

#### **Massachusetts Drinking Water Systems**

The Department of Environmental Protection regulates all public water systems in Massachusetts and enforces the SDWA through a primacy agreement with the USEPA. Public water systems are drinking water systems that serve at least 15 service connections or serve an average of at least 25 people daily at least 60 days per year.

As of SFY 2023, there are 1,603 public water systems in the Commonwealth of Massachusetts, comprising the categories identified in Table A. Approximately 33% of all public water systems are classified as community water systems (residential population), 15% are considered Non-Transient Non-Community systems (e.g. schools), and 52% are considered Transient Non-Community (e.g. campgrounds).

#### **EFFICACY OF THE CAPACITY DEVELOPMENT STRATEGY**

The objective of the 1996 Safe Drinking Water Act Amendments is to ensure that public water systems provide safe drinking water to the public. The Amendments seek to prevent compliance problems and associated health risks by ensuring that public water systems have the capability to produce safe drinking water now and in the future.

MassDEP's Capacity Development Strategy focuses on improving the technical, financial, and managerial operations of public water systems in the Commonwealth. Section 1420 of the SDWA requires MassDEP to continuously implement its strategy, The effective implementation of the Capacity Development Strategy (as outlined below in Section I – Components of the Capacity Development Strategy), has resulted in an increase in the percentage of systems meeting all health based standards as well as an increase in the percentage of the population getting water from systems meeting all health based standards (as described in Section II – Efficacy of the Capacity Development Strategy).

The following list of accomplishments (for the period July 1, 2020 – June 30, 2023) is indicative of the effectiveness of this program.

#### I. Components of the Capacity Development Strategy

A. New System Review for Community and Non-Transient Non-Community Systems (as required by SDWA Sec 1420 (c))

The MassDEP drinking water staff is responsible for evaluating (via a New System Business Plan and/or Sanitary Survey) the technical, financial and managerial capability of any <u>new</u> Community and Non-Transient Non-Community public water system. MassDEP staff also completes an evaluation on any new Transient Non-Community system. During the last three years the drinking water staff has completed the following number of evaluations (Figure 1). See Appendix A for a listing of the new PWS that registered between SFY 2021 – SFY 2023.

#### B. Existing System Review (as required by SDWA Sec 1420 (c))

The MassDEP drinking water staff is responsible for evaluating (via a Sanitary Survey) the technical, financial and managerial capability of any Community, Non-Transient Non-Community and Transient Non-Community public water system. During the last three years the drinking water staff has completed one thousand one hundred and forty (1,140) sanitary survey evaluations. Figure 2 provides a breakdown in the number and types of systems that had sanitary survey evaluations completed during SFY-2021 – SFY-2023. A full list of the public water systems that performed sanitary surveys between SFY 2021 – SFY 2023 is available in Appendix B, organized by SFY.

C. Scheduled Actions (Technical, Financial and Managerial (TFM) deficiencies) identified during Sanitary Surveys

During the SFY 2021 – SFY 2023 Sanitary Survey process, MassDEP staff identified a total of 2,712 Scheduled Actions (TFM deficiencies). See Figure 3 below for a comparison of the number of scheduled actions identified during SFY 2021 – SFY 2023.

Further analysis of the 2,712 Scheduled Actions identified above in Figure 3 (SFY 2021 – SFY 2023) is captured below in Figure 4. The DWP staff analyze the Scheduled Actions annually (Figure 4) to identify what type of training and technical assistance is needed to address PWS deficiencies. The analysis is distributed to drinking water training organizations and technical assistance providers including, but not limited to, Massachusetts Water Works Association, New England Water Works Association, Massachusetts Rural Water Association and RCAP Solutions. It is important to note that the "Issues" identified in Figure 4 reflect the age of a regulation, extreme weather changes, and survey cycle.

The PWS are required to address all identified deficiencies during an agreed upon time frame or face the possibility of penalties and progressive enforcement. The detailed capacity issues and compliance actions identified below demonstrates that MassDEP is taking an active role in improving the technical, financial and managerial health of public water systems.

#### D. Stakeholder Involvement

MassDEP continues to partner with stakeholders (non-profit organizations, universities, environmental agencies, and public water systems) to provide training and support to public water systems. MassDEP has partnerships with stakeholders such as the University of Massachusetts – Amherst, Massachusetts Rural Water Association, New England Water Works Association, and Massachusetts Water Works Association. Training topics include asset management, leak detection, cybersecurity, water sampling, operator exam preparation, and regulatory updates regarding Lead and Copper, Total Coliform, and PFAS.

After analyzing the deficiencies in Figures 3, 4 and 5 and completing an analysis of MassDEP and PWS compliance needs, the training topics listed in Figure 6 (below) were taught to public water systems and other interested entities by both MassDEP and various stakeholders.

#### E. Drinking Water Program – Capacity Development via Web-Based Tools

MassDEP, through its Drinking Water Program (DWP), administers and enforces the requirements of the federal SDWA. To further enhance MassDEP's efforts to promote public health and improve the technical, financial and managerial operations of public water systems MassDEP has developed (3) communication tools which are described below. #### F. Drinking Water Program – Asset Management

MassDEP's Capacity Development Strategy was updated in February 2022 to include additional provisions regarding the importance of asset management for capacity development. MassDEP considers asset management one of the best ways to achieve adequate capacity within the limited resources that water systems possess. Since adopting asset management into the updated Capacity Development Strategy, MassDEP has offered Asset Management Training Workshops to encourage the development of Asset Management Programs. During these workshops, participants learned how to develop the components of an Asset Management Plan and gain the knowledge and confidence to grow their water system's Asset Management Program over time. MassDEP also used DWSRF monies to support the creation of Asset Management Plans through grants and planning loans. In addition, water systems with an approved Asset Management Plan received priority points for the funding of projects that are a result of implementing the Asset Management Program. MassDEP continues to emphasize the importance of asset management and support water systems in their creation of asset management plans.

#### G. Drinking Water Program – Small and Disadvantaged Systems Support

In many of its initiatives, MassDEP prioritizes providing support to small and disadvantaged water systems throughout the state. MassDEP offers several grants and funding opportunities that give priority to small and/or disadvantaged systems fund efforts related to planning, reporting, or other system operations. For Lead and Copper Rule compliance and the inventory and replacement of lead service lines, MassDEP has prioritized assistance to systems serving small and/or disadvantaged communities. MassDEP is administering funds through the EPA's Emerging Contaminants – Small and Disadvantaged Communities Grant Program to small and disadvantaged communities to address PFAS and other emerging contaminants. MassDEP also administers funds through EPA's Small, Underserved, and Disadvantaged Communities Grant Program to small and disadvantaged communities with primary water quality violations. MassDEP partners with technical assistance providers and other stakeholders to provide training and other resources to these systems.

#### ii. Efficacy of the Capacity Development Strategy

MassDEP's Capacity Development Strategy fulfills the requirements of the SDWA by demonstrating that the initiatives described above have had a direct and positive impact on the quality and quantity of drinking water in Massachusetts. MassDEP believes that as a direct result of the technical and compliance assistance, education and outreach programs associated with the Capacity Development Strategy and provided by the MassDEP, the public water systems in Massachusetts have improved their technical, financial and managerial operations and their consumers/customers are drinking water that consistently meets all required federal and state standards. Specifically, Massachusetts exceeds the National GPRA Target for GPRA-Community Systems (87%) and is slightly below the National GPRA Target for GPRA-Population Population (92%) (see Figure 7). The GPRA statistics are calculated each quarter using the most recent 4 quarters of health-based compliance information in SDWISFED for community systems. The statistics indicate that 96.5% of GRPA-community systems provide, and 91.0% of Massachusetts population served by CWSs receive, drinking water that meets all applicable health-based drinking water standards through approaches including effective treatment & source water protection.

It is MassDEP's position that as a direct result of the technical assistance, education and outreach programs associated with the Capacity Development Strategy and provided by the DWP, the public water systems in Massachusetts have improved their technical, managerial and financial operations and their consumers/customers are drinking water that consistently meets all required federal and state standards.

#### **APPENDIX C**

#### GLOSSARY OF TERMS AND ACRONYMS USED IN THIS REPORT

**Capacity:** Refers to the capabilities required of a public water system in order to achieve and

maintain compliance with the drinking water rules. It has three elements:

**Technical:** Technical capacity or capability means that the water system meets

standards of engineering and structural integrity necessary to serve customer needs. Technically capable water systems are constructed, operated, and maintained according to accepted quality standards.

Financial: Financial capacity or capability means that the water system can raise

and properly manage the money it needs to operate efficiently over the

long term.

Managerial: Managerial capacity or capability means that the water system's

management structure is capable of providing proper stewardship of the system. Governing boards or authorities are actively involved in

oversight of system operations.

MassDEP: The Department of Environmental Protection. This agency is responsible for

administering the drinking water rules in our state.

**DWSRF:** The Drinking Water State Revolving Loan Fund. Congress authorized this fund in 1996.

In Massachusetts, MassDEP administers the DWSRF.

**EPA:** Environmental Protection Agency. This federal agency oversees state programs, sets

MCLs and provides technical assistance. EPA determines when a state's capacity

development program is in compliance with the Safe Drinking Water Act.

MCL: Maximum Containment Level. This is the maximum allowable level for a given drinking

water contaminant.

**PWS:** Public Water System as defined in the Safe Drinking Water Act.

SDWA: The Safe Drinking Water Act passed by the US Congress in 1974 and amended in 1986

and 1996.

**TFM:** Technical, financial, and managerial. The abbreviation is used to save space in the report

and avoid frequent repetition of these terms.
