Recipient will use the Research Material in the evaluation of contaminants in environmental media, namely, in identifying compounds likely to be identified in nontargeted chemical analysis. The recipient will select options in the Research Material that mimic laboratory method steps potentially including, but not limited to, instrument platform, ionization technique, extraction solvents, solid phase extraction method, elution buffers, analytical columns, mobile phase and mobile phase additives to predict which compounds included in the Research Material database are extractable, detectable, and identifiable using the Recipients methodologies. This predicted subset of chemical compounds will be used to better understand what compounds are and are not within the scope of the Recipients nontargeted chemical analysis research projects. Additionally, the information gleaned from use of the Research Material will help the Recipient calculate accuracy and quality control metrics on their datasets. The Recipient will use the Research Material on a multitude of projects and methods development projects including nontargeted chemical analyses of water, soil, sludges, biota, tissue, and bed sediment.

6. In all oral presentations or written publications concerning the Research Project, RECIPIENT will

acknowledge PROVIDER's contribution of this Research Material unless requested otherwise. RECIPIENT agrees to protect the information claimed as confidential business information from unauthorized disclosure to the extent permitted by law and consistent with EPA's regulations under 40 C.F.R. Part 2, Subpart B. The foregoing shall not apply to information that is or becomes publicly available or which is disclosed to RECIPIENT without a confidentiality obligation. In asserting a claim for protection, the PROVIDER must stamp its Research Material as "CLAIMED AS CONFIDENTIAL BUSINESS INFORMATION."
