

Brownfield Grant Funding Opportunities

The fiscal year (FY) 2024 Brownfields Multipurpose, Assessment and Cleanup Grant (MAC) Guidelines are now available in <u>www.grants.gov</u> and on the EPA MAC Grant Application Resources <u>webpage</u>, along with other General Program Resources.

The application submission deadline is **November 13**, **2023**.

Brownfields Tribal Response Program Workshop Denver, CO - November 7-8, 2023

EPA Regions 7 and 8 and KSU TAB will be hosting a Brownfields Tribal Response Program workshop in Denver on November 7th and 8th. The purpose of the workshop is to learn from peers, understand grant requirements, and gain inspiration to put Bipartisan Infrastructure Law (BIL) funds to good use! The Tribal Brownfields Coordinators are the intended audience, but other relevant tribal staff and managers are also welcome. Brownfields 128(a) funds can be used to pay for travel to Denver. A Targeted Brownfields Assessment (TBA) is an environmental investigation that documents environmental conditions at a property under consideration for redevelopment or reuse. These are conducted at no cost to communities requesting assistance. Applications are accepted and assessments are performed throughout the year. Click <u>here</u> to apply.

<u>Brownfields JT Grants</u> are 5-year, \$500,000 grants and are available for nonprofit organizations, Indian Tribes, redevelopment agencies, regional councils, public and nonprofit colleges, and State & local governments. Grantees can tailor their training curriculum to the job market needs of their Brownfields community and provide a variety of trainings.

Grantee Success Stories

Missoula Old Sawmill District, MT

New life and land have been revitalized in the 46-acre Old Sawmill District in the form of a 14-acre riverfront park and residential and commercial properties through Brownfields funds and partnership between EPA and the City of Missoula.

R8 EPA Regional Administrator, KC Becker visited the Old Sawmill District in Missoula, MT with Missoula Mayor, Jordan Hess on June 7, 2023, to see firsthand the successful redevelopment that has taken place in this community.

Missoula leveraged a Brownfields Revolving Loan Fund grant to revitalize 46-acres which was previously used as a lumber mill beginning in 1900. After being left vacant and declared blighted in the 1990s, the process to redevelop the land began. With funding from EPA for the past two decades, the City of Missoula has cleaned up scores of acres and leveraged over \$185 million in redevelopment of underutilized properties.

EPA Deputy Administrator visits Montana

On August 29th, Deputy Administrator McCabe joined EPA Region 8's Regional Administrator Becker on a trip that included visiting two Brownfield grant recipients, Northern Cheyenne Tribe and Big Sky Economic Development Authority. The Northern Cheyenne leadership and environmental staff met with EPA and gave a tour of successful Brownfields sites. In Billings, there was a downtown Brownfields walking tour, followed by a meeting with the Mayor Bill Cole and other Billings leaders to discuss the Brownfields program implementation and impacts. Baatz Building in Great Falls, MT

Great Falls Development Authority (GFDA) has awarded a \$583,925 subgrant to NeighborWorks Great Falls using their EPA Brownfields Revolving Loan Fund (RLF) grant to clean up asbestos, lead, PCBs, and other contamination in the Baatz Building. This subgrant award is leveraging more than \$10,000,000 of additional funds towards the project's total redevelopment cost. Abatement is set to begin this fall to redevelop this historic building into 25 supportive housing units with community services on the main floor. This is another great example of how Brownfields
