

## PART I – REQUIREMENTS FOR NPDES PERMITS

## SECTION A. LIMITATIONS AND MONITORING REQUIREMENTS

## 1. Outfalls 001

During the period beginning the effective date of the permit and lasting through the dismantle of Outfall 001, the permittee is authorized to discharge storm runoffs from storage and production areas, once-through cooling water, cleaning water, and Artesian well water from Outfalls 001. Such discharges shall be limited and monitored by the permittee as specified below (1):
