Ekewe nimengawen ewe kaar non ekewe neni mei tongeni efeiengawa menun won fenu me menun non sat, mei pwan efeiengaw ngeni aramas pwe mei wor ekewe metoch mei poison ren asbestos, lead, ika arsenic. Ekewe karren pisek pwan nusin nimengawen ewe kaar mei tongeni paras fetan seni pingin ran, asepan, pwan seni ewe aruwouwan kinikin angang ika pwan mei tongeni paras fetan ika ewor chon aparasa fetanei ekewe nimengawan karr.

Io ka rakan memes won aieaan ewe soil stabilizer?

Ewe muun Maui me ekewe kinikin seni an Hawaii we ofesin Health DOH, Federal Emergency Management agency, (FEMA) US Army corps of Engineers (USACE) Pwan ewe ofesin Environmental protection agency (EPA) Irr ra epungueno aieaan ewe soil stabilizer an epwe aninis ngeni ekewe nimengawen ewe karr.

EPA repoputa aieaa ewe soil stabilizer non Kula nesoponan ewe september 2023. EPA epoputa aieaa Soiltac non Lahaina non nukanapan ewe october, me mwrin an mayor in Maui we epungueno ar repwe aieaa.

Met Ekewe sia ekieki pwe ekewe nimengawan ewe kaar epwe feor ngeni manauen aramas?

Ekewe karren metoch ika nimengawen ewe karr mei wor non ekewe metoch mei poison ren asbestos, lead, arsenic pwan ekoch me nukin. **Aiea'an ekwe pisekin safety mei euehea omw kopwe aiea'a nupwen kopwe angang ngeni ekewe nimengawan kaar. Pwe epwe epetuk seni poisonin ekewe nimengawan kaar.**

- Menun nimengawen ekewe kaaren metoch, mei kukkun, mei tongeni tonong non an emon anen nenien asepan iwa afeorata an epwe nawanaw, metek non pwotun, weiresin ngas, tori sainen alerchik pwan waten mworr ika kichimwor.
- Ekewe nimengawen karr mei wor watten pH non mei tongeni ameteki mesan aramas ika pwan ngeni semwenin uwenuchach.
- Ewe nimengawen kaar mei efeiengaw ngeni an aramas health. mei wor ekewe metoch mei poison non awewe ren chon asbestos, lead, arsenic. Ika pwe emon epwe nomw etam non ekewe neni mei wor ekewe metoch mei poison non, ewe aramas mei tongeni urii semwein ngasangas, tori stroke, kanserin ammat pwan urri ekoch semwen epwe aweiresi an ngasangas.

Meta eochin aeian ewe soil stabilizer?

- Aeaan ewe soil stabilizer mei ekuku nona an aramas repwe ngasengasete non poisonun ekewe kaar.
- Epwan aninis ngeni an ekewe nimengawen ewe kaar epwe towu nukin.
- Aeia'an ewe soil stabilizer epwan eninis ngeni an ewe poison esapw tori sat, esapw tori ekewe och pwan menun non ewe sat.

Ian repwe aiea ian ewe Soil stabilizer?

- Ewe EPA Team repwe aiea'a ewe stabilizer on ekewe nemwon fetan won ekewe nimengaw, nge resapw pwan aiea'a non ekewe neni mei euehea ngenichon ewe fenu. Ewe Ash ika ewe nimengawen ewe kaar mei wate poisonin nge mei need an epwe safei, Ewe soil stabilizer epwe nimetiano ewe nusin nimengaw non ewe eruwouwan angang.

Ifan ekewe steps in ar repwe aieaa soiltac?

Me mwen aieaan ewe metoch, ekewechon angangen EPA pwan ekewe ra memes won pekkin eoreni repwe checki eochu ewe ukukun safei ika soil stablizer ra aiea'a non ekewe neni pwe esapw efeiengaw ngeni menun won fenu, pwan ekewe nenien amwongon man pwan ekoch neni.

Ewe soil stabilizer **resapw** aieaa non ekewe neni mei euehea ngenichon ewe fenu ren pekkin ar eoreni ika pwan ekewe neni rafen esisina pwe resapw watiw ewe safei ie.

- Ekewechon angang ren pekkin culturein ewe fenu repwe esinei ngeni ekewe EPA team pwe repwe check safei ni nukin ekewe neni mei eueha ngenichon ewe neni, mwiri repwap check i eochu non ewe step 2.
- Iei ekewe metoch **resapw** spray ni ika safei ni:
 - nenien peias,
 - walls,
 - neun fan Bells, ekewe nios ike metoch mei wor wewen ngeni ewe neni, an Waiola imwen fan, Pioneer Mill Co, ofes pwan an Lahina stowa
 - pwal ekewe pisek mei euehea pwan wor wewen ngeni ewe culture, pwan ekewe peas en soma mei nomw non ewe imw non Baldwin, Wo Hing, pwan Shingon Mission.

Epwe ifa usun nikinikin ekewe karren pisek ika nimengau me murin?

- Ewe soiltac ese poison ika awesino angang en. Ra aiea'a won ewe pun pwan tumunun ewe dust an esapw paras fetan.
- Wesinon aiea'an ewe Soiltac mei aninis ngeni ekewe US Army corpse of Engineers ar repwe feorkuna eochui ar angang non ewe kinikin angang nampa 2, amwokutin ekewe nimengaw epwe amechersi ngeni anchon ewe neni repwe kuna pisekir kewe mei taano.

Met aramas repwe tongeni katon, atapa ika pwan checki fetanei pisekir kewe me mwirin an ekewe chon angang aiea soil stabilizer won?

- Ewer, ekewe rekan checki ekewe neni, mei mecheres ngenir ar repwe kuna eochu ika remochen emwekutu ekewe metoch.
- EPA e rekuest an aramas repwe witiwit non 24 awa me mwirin ewe sefei epwe pechekun ika won ekewe metoch mei kar. EPA epwe pacheita ekewe sain non ekewe neni ika ra poputa sefei ni epwe pun.

Epwe ian ika u atai enukun ewe Soil stabilizer? en mei tongeni niwin sefan kapwan feori?
