# Profiles in Leadership "Areas of Emphasis" Definitions



#### Corporate Social Responsibility/Environment & Social Governance

 CSR/ESG is a management concept that focuses on the integration of social and environmental concerns in a company's business operations (e.g., ESG, greenhouse gases (GHG) accounting/reporting, GHG target setting and goals, freight sustainability-related or community-related to minimize environmental footprint).

#### Forecasting Innovation Trends in Freight Transportation

 Identifying or foretelling of changes/developments in the freight sector that have the potential to result in behavior shifts or advances of new technologies. The expectation is that the potential to impact freight sustainability is significant.

#### Freight Research

 Studies, testing, or pilots conducted to better understand fuel efficient technologies or supply chain freight efficiency practices to reduce emissions.

# Profiles in Leadership "Areas of Emphasis" Definitions



#### Information System and Data Innovation

 Recent innovations in the acquisition, integration/fusion, analysis, modeling, or visualization of freight data; data tools that are adaptable and user-friendly freight systems that leverage innovative private and public data sources while preserving their proprietary nature (e.g., use of real-time transportation visibility data, digital dashboards, artificial intelligence, application program interfaces, integration of freight-efficiency modules into business systems).

#### Influential Collaboration

 Those intentional cooperative endeavors that advance freight sustainability, including modeling and championing accountability, inspiring market and industry transformations impacting how freight is moved and sharing successful efficiency strategies within the freight industry.

#### Strategy/Operations Innovation

 Novel and optimal ways to move and deliver goods more efficiently in the supply chain network (e.g., integration of new supply chain freight efficiency practices to reduce empty miles).

# Profiles in Leadership "Areas of Emphasis" Definitions



#### Sustainability Education and Socialization

 All internal and external actions to educate employees, customers, suppliers, colleagues, members, and investors about your freight sustainability efforts, how SmartWay helps with doing that work and incorporating sustainability values as part of a normal way of doing business.

#### Technology Innovation

 New equipment or associated supporting infrastructure to move and deliver goods more efficiently in the freight supply chain network. (e.g., electric or alternatively powered vehicles, autonomous vehicles, etc.)

#### Other

 In the event an Affiliate or eligible Partner company wishes to be recognized for leadership actions that don't nicely fit into the Areas of Emphasis categories above, an application may be submitted under the "Other" option.

### **Selection Criteria**



- Eligible Partners with two years of on-time SmartWay Tool submissions with quality data
- Completed Profiles in Leadership applications will be evaluated on a point system that that considers:
  - Clarity and completeness of application responses
  - Quality and substance of summaries and descriptions
  - Actual achievements, true innovation (actions, strategies, technologies), emissions reductions, fuel savings, as well as significant impact and influence
  - Evidence, proof or documentation that substantiates submissions via weblinks or digital attachments (No hard copies accepted)



### **Additional Considerations**

- Only self-nominations from Partners and Affiliates will be accepted
- Profiles in Leadership candidates may be screened for any adverse environmental actions that may prohibit public recognition for their SmartWay or freight sustainability leadership achievements
- EPA encourages submission of your company logo, a picture/photo associated with this project, or other relevant graphics and charts which highlight results or outcomes

#### 2024 SmartWay Profiles in Leadership — EPA Criteria

#### WHAT ARE THE SMARTWAY PROFILES IN LEADERSHIP?

New in 2024, EPA is recognizing freight sustainability leadership actions for some Partner categories and Affiliates, SmartWay defines leadership as the ability to drive change, influence industry, lead freight efficiency performance, and sustain freight environmental excellence. Areas of emphasis for Profiles in Leadership recognition include:

- Corporate Social Responsibility/Environmental. Social and
- Freight Research
- Forecasting Innovative Trends in Freight Transportation
- Influential Collaboration
- · Information System and Data Innovation
- Sustainability Education and Socialization
- Strategy/Operations Innovation
- Technology Innovation
- Other

SmartWay categories eligible for consideration are:

- Affiliates
- Logistic Companies Rail Cariers
- Air Carriers
- Barge Carriers

All the above Partner categories, with two years of on-time SmartWay Tool submissions and quality data, as well as Affiliates are invited to complete and submit SmartWay Leadership Profile form to EPA for consideration.



For this inaugural year of the Profiles in Leadership, EPA SmartWay will accept self-nominations from a Partner company or an Affiliate organization about its efforts and accomplishments. EPA may consider nominations from external parties in the future.



Profiles in Leadership candidates may be screened for any adverse environmental actions that may prohibit public recognition for their SmartWay achievements.



☆☆ EPA will notify those Partners and Affiliates selected for recognition under the Profiles in Leadership recognition program ognition under the Profiles in Leadership recognition program.

Please note that shipper and truck carrier Partners are not eligible for Profiles in Leadership during this inaugural year. EPA may reconsider the eligibility of shipper and truck carrier Partners for Profiles in Leadership recognition in the future.





#### WHAT ARE THE KEY DATES: TIMELINE AND NOTIFICATION?

January 2024: Affiliates and Partners (logistics companies, air carriers, barge carriers, and rail carriers) with two years of on-time SmartWay annual data submissions are invited to submit an online SmartWay Leadership Profile form to FPA for consideration

JULY 29: Submission deadline for Profiles in Leadership forms from Partners (logistics companies, air carriers, barge carriers and rail carriers) and Affiliates.

AUGUST-SEPTEMBER: Final reviews and adverse environmental actions screening.

OCTOBER: Notification that individual Partners and Affiliates will be featured as Profiles in Leadership selectees will occur via email (no public announcement until fall)

NOVEMBER: Public announcement of those Partners and Affiliates selected for SmartWay Profiles in Leadership.

### 2024 Timeline: SmartWay Profiles in Leadership Recognition

February 2024	Profiles in Leadership application available online for Logistics Company, Air carrier, Barge carrier and Rail carrier Partners, as well as Affiliates.  Eligible Partners and Affiliates are invited to submit a Profiles in Leadership application.

Integrate Partner input and refine Excellence Award and Leadership criteria as appropriate.

## July 29, 2024 Profiles in Leadership application deadline.

December 2023

Aug – Sept 2024 EPA conducts final reviews and adverse environmental actions screening.

October 2024 Individual Partner and Affiliate notification of SmartWay Leader selection via private email.

Late November 2024 Public announcement of 2024 SmartWay Leaders.
